**WITHDRAWAL ORDER**

Whereas, the WRC had granted the recognition to Sarvodaya College of Education, 16/2, B. H. Complex, Near Utkarsh Petrol Pump, Karelbaug, Baroda, Gujarat - 390018 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/98<sup>th</sup>/2007/C-17967 dt. 21.06.2007.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Sarvodaya College of Education, 16/2, B. H. Complex, Near Utkarsh Petrol Pump, Karelbaug, Baroda, Gujarat - 390018 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 29.01.2015 from the institution, a revised recognition order no. WRC/APW04062/323398/2015-138347 dt. 29.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 29.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014 :-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255<sup>th</sup> meeting held on June 22<sup>nd</sup> - 24<sup>th</sup>, 2016 and the Committee decided to issue Show Cause Notice dt. 22.08.2016.

And whereas, reply dt. 03.09.2016 was submitted by the institution placed before the WRC in its 283<sup>rd</sup> meeting held on November 14<sup>th</sup> - 15<sup>th</sup>, 2017 and the Committee decided as follows :-

"The case file was seen. As per Revised Recognition order, the institution has submitted documents as required. However, the staff profile approved by the affiliating body should be submitted in original.

Building Completion Certificate signed by a Govt. Engineer and additional Reserve Fund of Rs.4.00 lakhs should be submitted in original.

Compliance should be submitted by the institution within one month, failing which action will be initiated as per NCTE Regulations, 2014."

And whereas, the WRC vide letter dt. 21.11.2017 was issued to the institution.

And whereas, reply dt. 01.12.2017 was submitted by the institution was placed before the WRC in its 290<sup>th</sup> meeting held on March 21<sup>st</sup> - 23<sup>rd</sup>, 2018 and the Committee decided as follows :-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 22.08.2016 followed by a compliance letter dated 21.11.2017 was issued. The institution replied on 01.12.2017.

The institution has submitted a staff profile of 1+7 faculty members which is approved by the affiliating body. However, lecturer at S.No.2 does not have the required percentage at PG level.

Secondly, the institution has not submitted a Building Completion Certificate in the prescribed format.

FDR for Rs.4.00 lakhs only has been submitted.

Hence, Recognition is withdrawn from the end of the next academic session."

Now, therefore, the recognition Sarvoday College of Education, 16/2, B. H. Complex, Near Utkarsh Petrol Pump, Karelibaug, Baroda, Gujarat - 390018 for conducting B.Ed. programme of two years duration with an annual intake of 100 seats (two basic units of 50 students), is **hereby withdrawn from the academic session 2018-2019** in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
