RESTORATION ORDER

200644

Whereas, recognition was granted to the institution, namely, Sarvoday College of Education, 16/2, B. H. Complex, Near Utkarsh Petrol Pump, Karelibaug, Baroda, Gujarat - 390018 under section 14 of NCTE Act, 1993 for conducting B.ED. course with an annual intake of 100 students vide order no. WRC/5-6/98th/2007/C-17967 dt. 21.06.2007.

2. And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Sarvoday College of Education, 16/2, B. H. Complex, Near Utkarsh Petrol Pump, Karelibaug, Baroda, Gujarat - 390018 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

3. And whereas, after the receipt of affidavit dt. 29.01.2015 from the institution, a revised recognition order no. WRC/APW04062/323398/2015/138347 dt. 29.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-16.

4. And Whereas, the matter was placed before the WRC in its 255th Meeting held on June 22-24, 2016 and the Committee decided to issue show cause notice dt. 22.08.2016.

5. And whereas, reply dt. 03.09.2016 was placed before the WRC in its 283rd meeting held on November 14-15, 2017 and the Committee decided as follows:-

"The case file was seen. As per Revised Recognition order, the institution has submitted documents as required. However, the staff profile approved by the affiliating body should be submitted in original.

Building Completion Certificate signed by a Govt. Engineer and additional Reserve Fund of Rs.4.00 lakhs should be submitted in original.

Compliance should be submitted by the institution within one month, failing which action will be initiated as per NCTE Regulations, 2014."

6. And Whereas, a conveyed letter no. WRC/APW04062/323398/B.Ed./Guj./2017/193178 dt. 21.11.2017 was issued to the institution.

7. And whereas, reply dt. 01.12.2017 was placed before the WRC in its 290th meeting held on March 21-23, 2018 and the Committee decided as follows:-

" The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 22.08.2016 followed by a compliance letter dated 21.11.2017 was issued. The institution replied on 01.12.2017.

The institution has submitted a staff profile of 1+7 faculty members which is approved by the affiliating body. However, lecturer at S.No.2 does not have the required percentage at PG level.

Secondly, the institution has not submitted a Building Completion Certificate in the prescribed format.

FDR for Rs.4.00 lakhs only has been submitted.

Hence, Recognition is withdrawn from the end of the next academic session."

8. And Whereas, a withdrawal order no. WRC/APW04062/323398/Guj./290th/2018/196810 dt.04.04.2018 was issued to the institution.

9. And Whereas, the institution has filed an appeal at NCTE Hqrs. New Delhi and the Appellant Authority vide order dt. 12.09.2018 has decided as follows:-

"After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing the Committee concluded that the matter deserved to be remanded to the WRC with a direction to consider these documents to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the W.R.C. the documents submitted in the appeal within 15 days of receipt of the orders on the appeal. In the meanwhile, the order of withdrawal shall be kept in abeyance.

The Council hereby remands back the case of Sarvoday College of Education, shamaldevi, Kalol, Gujarat to the WRC, NCTE, for necessary action as indicated above."

10. And Whereas, reply dt. 22.09.2018 of institution was placed before the WRC in its 299th meeting held on October, 30 – November 1, 2018, and Committee decided as follows:-

"This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC with a direction to consider these documents, to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014.


On perusal of the reply dated 22.09.2018, the Committee observed that:-

- (i) The institution has submitted the approved staff list of 1+15 faculty members.*
- (ii) Building Completion Certificate duly signed by competent authority submitted.*
- (iii) FDR for Rs.12.00 lakhs as required under clause 10(1) of NCTE Regulations, 2014 submitted.*

Hence, the Committee decided that Recognition of the institution be restored for two units of B.Ed. course."

11. Now Therefore, this restoration order is issued as per decision of the WRC in its 299th meeting as cited above.

12. Contravention of any of the provisions of the NCTE Act, 1993, NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution. as defined under NCTE Act, 1993 and NCTE Regulations, 2014.


