## Restoration of Recognition Order

Whereas in terms of Section 14(3) (a) of the NCTE Act, 1993, Sardar Patel Mahila B.ED College At.Vadnagar, Ta. Vadnagar, Mehsana-384355, Gujarat (Code No.APW01537/323233) has granted recognition for conducting B.ED course with an annual intake of 100 students vide order No. WRC/2-32/323233/73/2005/4720 dt. 21.06.2005.

And whereas in its 109<sup>th</sup> meeting held on October 19<sup>th</sup>-20<sup>th</sup>, 2008 the Western Regional Committee after considering the report of the visiting team as well as other relevant material furnished by the applicant institution decided to withdraw the recognition of the said institution for B.ED course under section 17 (1) of NCTE Act, 1993 and accordingly the withdrawal order was issued vide order No. WRC/APW01537/323233/110/2008/50300 dated 24.01.2008 to the institution from the end of the academic session.

And whereas in compliance of order passed by Hon'ble High Court of Gujarat at Ahmedabad in SCA No.3205/2008 and related matter inspection of the institution was conducted on 28.03.2011.

And whereas the VT report alongwith original file of the institution was placed in 148<sup>th</sup> meeting of WRC held on April, 10<sup>th</sup> -12<sup>th</sup>, 2011 and committee decided to restore the recognition of the institution.

Now therefore, in exercise of the powers sted under Section 14(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby restore recognition of Sardar Patel Mahila B.ED College At.Vadnagar, Ta. Vadnagar, Mehsana-384355, Gujarat granted vide order No. WRC/2-32/323233/73/2005/4720 dt. 21.06.2005 for conducting D.ED course for a basic unit with an annual intake of 100 seats.
