Whereas, the WRC had granted the recognition to Sardar Patel Mahila B.Ed. College, Vadnagar, Mehsana, Gujarat - 384355 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/2-32/323233/73/2005/4720 dt. 21.06.2005.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Sardar Patel Mahila B.Ed. College, Vadnagar, Mehsana, Gujarat - 384355 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 09.01.2015 from the institution, a revised recognition order no. WRC/APW01537/323233/2015/143631 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 50 seats (one basic units of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014:-

- 1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
- 2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
- 3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255<sup>th</sup> meeting held on June 22<sup>nd</sup> – 24<sup>th</sup>, 2016 and the Committee decided to issue Show Cause Notice dt. 29.08.2016.

And whereas, reply dt. 10.09.2016 was submitted by the institution placed before the WRC in its  $283^{rd}$  meeting held on November  $14^{th}$  –  $15^{th}$ , 2017 and the Committee decided as follows:-

"The case file was seen. As per Revised Recognition order, the institution has submitted documents as required. However, the staff profile approved by the affiliating body should be submitted in original.

Building Completion Certificate signed by a Govt. Engineer and FDRs of Rs.12.00 lakhs (in joint name) should be submitted in original.

Compliance should be submitted by the institution within one month, failing which action will be initiated as per NCTE Regulations, 2014."

And whereas, the WRC vide letter dt. 17.11.2017 was issued to the institution.

And whereas, reply dt. 11.12.2017 was submitted by the institution was placed before the WRC in its  $290^{th}$  meeting held on March  $21^{st} - 23^{rd}$ , 2018 and the Committee decided as follows:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 29.08.2016 followed by a compliance letter dated 17.11.2017 was issued. The institution replied on 11.12.2017.

A scrutiny of the reply shows that out of the 1+7 faculty members, the Registrar has not approved the appointments at S.No.6, 7 & 8.

Secondly, the institution has not submitted a Building Completion Certificate in the prescribed format counter signed by a Govt. Engineer in original.

Hence, Recognition is withdrawn from the end of the next academic session.

Now, therefore, the recognition Sardar Patel Mahila B.Ed. College, Vadnagar, Mehsana, Gujarat -Now, conducting B.Ed. programme of two years duration with an annual intake of 100 seats (two 84355 roll students), is hereby withdrawn from the academic session 2018-2019 in terms asic units of 100 seats (two asic units of 100 seats). Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New pelhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of his order. The guidelines of appeal are enclosed herewith.
