RESTORATION ORDER

Whereas, recognition was granted to the institution, namely, 2014 Sardar Patel Mahila B.Ed. College, Vadnagar, Mehsana, Gujarat - 384355 under section 14 of NCTE Act, 1993 for conducting B.Ed. course with an annual intake of 100 students vide order no. WRC/2-32/323233/73/2005/4720 dated 21.06.2005.

- 2. And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Sardar Patel Mahila B.Ed. - 3. And whereas, after the receipt of affidavit dt. 09.01.2015 from the institution, a revised recognition order no. WRC/APW01537/323233/2015 /143631 dt 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 50 students (one basic units of 50 students each) from session 2015-16.
- 4. And Whereas, the matter was placed before the WRC in its 255th Meeting held on June 22-24, 2016 and the Committee decided to issue show cause notice dt. 29.08.2016 to the institution.
- 5. And Whereas, reply dt. 10.09.2016 of institution was placed before the WRC in its 283rd meeting held on November 14th 15th, 2017 and Committee decided as follows:-

"The case file was seen. As per Revised Recognition order, the institution has submitted documents as required. However, the staff profile approved by the affiliating body should be submitted in original.

Building Completion Certificate signed by a Govt. Engineer and FDRs of Rs.12.00 lakhs (in joint name) should be submitted in original.

Compliance should be submitted by the institution within one month, failing which action will be initiated as per NCTE Regulations, 2014."

- 6. And Whereas, a Conveyed letter no. WRC/APW01537/323233/B.Ed./283rd/Guj/2017/192854-2857 dt. 17.11.2017 was issued to the institution.
- 7. And Whereas, reply dt.11.12.2017 of institution was placed before the WRC in its 290th meeting held on March 21st 23rd, 2018 and Committee decided as follows:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 29.08.2016 followed by a compliance letter dated 17.11.2017 was issued. The institution replied on 11.12.2017.

A scrutiny of the reply shows that out of the 1+7 faculty members, the Registrar has not approved the appointments at S.No.6, 7 & 8.

Secondly, the institution has not submitted a Building Completion Certificate in the prescribed format counter signed by a Govt. Engineer in original.

Hence, Recognition is withdrawn from the end of the next academic session."

8. And Whereas, a withdrawal order no. WRC/APW01537/323233/ Guj. /290th/2018/196794 dt. 04.04.2018 was issued to the institution.

9. And Whereas, the institution had filed an appeal at NCTE Hqrs. New Delhi and the Appellant Authority vide order dt. 12.09.2018 has decided as follows:-

"After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the committee concluded that the matter deserved to ne remanded to the WRC with a direction to consider these documents to be submitted to them by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the WRC all the documents submitted in the appeal within 15 days of receipt of the orders on the appeal. In the meanwhile, the order of withdrawal shall be kept in abeyance.

The Council hereby remands back the case of L.N. Patel College of Education, Kalayanpura, Kadi, Gujarat

to the WRC, NCTE, for necessary action as indicated above."

10. And Whereas, reply dt. 21. 09. 2018 of institution was placed before the WRC in its 299th meeting held on October 30th - November 1st, 2018 and Committee decided as follows:-

"This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC for issue of revised appropriate orders as per NCTE Regulations, 2014 expeditiously.

On perusal of the reply dated 21.09.2018, the Committee observed that: -

- (i) The institution has submitted the approved staff list of 1+7 faculty members. Out of these, two faculty members at S.No.7 & 8 are not eligible as per NCTE notification published on 09.06.2017.
- (ii) Building Completion Certificate duly signed by competent authority submitted.
- (iii) FDR for Rs.12.00 lakhs in original as required under clause 10(1) of NCTE Regulations, 2014 not submitted.

Hence, the Committee decided that Show Cause Notice be issued to the institution. Reply should be submitted within one month, failing which recognition will be withdrawn u/s 17(1) of the NCTE Act, 1993."

- 11. And Whereas, show cause notice No. APW01537/323233/299th/B.Ed./Guj./2018/200648-650 dt. 15.11.2018 was issued to the institution.
- 12. And Whereas, reply dt. 27.11.2018, 17.05.2019 of institution was placed before the WRC in its 308th meeting held on June 19th-21st, 2019 and Committee decided as follows:-

"The Show Cause Notice was issued to the institution on 15/11/2018

The institution has submitted reply to Show Cause Notice on 27/11/2018 & 17/05/2019.

On perusal of the reply of the institution the committee observed that the reply of the institution is as per NCTE Regulations 2014 & amendment Regulations 2017.

Hence, the committee decided to restore the recognition of one unit of B.Ed. programme."

13. Now Therefore, the recognition granted to the institution for conducting B.Ed. course has been restored as per decision of the WRC in its 308th meeting and Institution is permitted to continue the existing B.Ed. Course of two years duration with an annual intake of 50 seats (one basic unit of 50 students).

14. It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.

Revised order no. WRC/APW01537/323233/2015/143631 dt 31.05.2015 be treated as cancelled from the date of issue of this order.
