**ORDER**  
**REDUCE IN INTAKE FOR B.ED. COURSE**

Whereas, the WRC had granted recognition to the institution namely, Taxashila B.Ed. College (run by Chanakya Education & Charitable Trust), Sara Road, Behind Vajinath Temple, At & Ta. Halvad, District - Surendranagar, Gujarat for conducting B.Ed. course of one year duration vide order no WRC/5-6/100th/2007/26163 dt. 10.01.2008.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide Gazette notification dt. 01.12.2014 the institution was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014.

And whereas, after the receipt of affidavit dt. 31.01.2015 from the institution, a revised recognition order no. WRC/APW04337/323431/2015/143849 dt. 31.05.2015 was issued to the institution for conducting B.Ed. course of two year duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014 :-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the institution hadn't submitted the documents in compliance of revised order and matter was placed before the WRC in its 255<sup>th</sup> meeting held on June, 22<sup>nd</sup> - 24<sup>th</sup>, 2017. The Committee decided to issue show cause notice. Accordingly a show cause notice dt. 24.08.2016 was issued.

And whereas, reply dt. 31.10.2016, submitted by the institution, was placed before the WRC in its 277<sup>th</sup> meeting held on June, 29<sup>th</sup> - 30<sup>th</sup>, 2017 and the Committee decided as follows :-

"The case file was seen. In response to the WRC letter dt. 24/08/2016, regarding fulfillment of requirements, the institution has submitted a list of 1 Principal and 11 faculty members (excluding Librarian). Out of these, lecturer at serial no. 10 does not have a Master's degree in the subject. In all, the institution therefore needs to appoint 5 more faculty members out of which 1 should be in Performing Arts and 1 in Fine Arts as per the NCTE Regulations, 2014.

Show Cause Notice be issued on the above grounds and reply should be received within 1 month."

And whereas, show cause notice no. WRC/APW04337/323431/B.Ed./Guj./2017/187101 dt. 04.07.2017 was issued to the institution.

And whereas, reply dt. 17.08.2017 submitted by the institution was placed before the WRC in its 282<sup>nd</sup> meeting held on October, 24<sup>th</sup> - 26<sup>th</sup>, 2017 and the Committee decided as follows :-

"The case file was seen. Show Cause Notice dated 04.07.2017 was issued to the institution regarding staff and the need to appoint five more faculty members. The institution has submitted a list of one Principal and 10 faculty members (excluding librarian) approved by the Registrar.

**Hence, Recognition is reduced to one unit for the B.Ed. course from the session 2018-2019."**

Now therefore, the annual intake of 100 students (two basic units of 50 students) granted to Taxashila B.Ed. College, (run by Chanakya Education & Charitable Trust), Sara Road, Behind Vajjnath Temple, Halvad, Surendranagar, Gujarat for conducting B.Ed. programme of two years duration is **hereby reduced to an annual intake of 50 students (one basic unit of 50 students) from the academic session 2018-2019.**

Other conditions mentioned in revised recognition order no. WRC/APW04337/323431/2015/143849 dt. 31.05.2015 will remain same.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17 (1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
