- The institution has initiated the process for recruitment of Principal/Head of (iv) Department and teachers for the said course.
- Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Shri G.V. Mayavanshi PTC College (Girls), At & Po. Ambav, Ta. Thasra, Kheda for PTC of two year from the academic session 2003-200 with an annual intake of 50 students subject to fulfillment of the following.
- The institution shall ensure that it gets duly affiliated for this course to the concerned Board/Directorate and all other formalities required by the Board/Directorate are also completed before the commencement of the course and admission of the students to the (a) course and a report to this effect should be sent to the Committee.
- That the institution will ensure that 06 (one Principal and 05 lecturers) faculty members are in position for an intake of 50 or less students before commencement of the course and a report to this effect duly verified by the Director of Primary Education shall be sent to the Committee (b)

- The institution shall within one month of the receipt of recognition create an endowment fund within one month of commencement of the course. account into a joint account to be operated along with an official of the Regional Committee. (c)
- The institution shall shift to its own premises within three years from the date of recognition (d)
- The institution shall comply with the various other norms and standards as prescribed in the (c) NCTE Regulations. PT

- 5. Further, the recognition is subject to the fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university/State Directorate of liducation to the appointment of faculty members and the statement of arnual accounts duly audited by a Chartered Accountant.
- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee Lay withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
