### ORDER

The following institution mentioned in para 3 below submitted applications to the Western Regional Committee of National Council for Teacher Education for grant of recognition to D.Ed. in terms of Section 14(1) and of NCTE Act, 1993, among others.

2. The WRC at its extended 87<sup>th</sup> meeting held on August 30-31, 2006 at NCTE, WRC, Bhopal considered applications of the institutions included in the Agenda for the meeting and after careful examination of relevant documents, Visiting Team Reports, Video Recording etc. found the institutions mentioned in para 3 below fit for grant of conditional recognition of the courses and intake mentioned against their names. Thereafter, the institutions submitted compliance reports removing deficiencies mentioned therein.

3. Now, therefore, in exercise of powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to these institutions w.e.f. the session 2006-2007 for the course and intake mentioned against their names and addresses shown as under.

4. The institutions shall ensure the fulfillment of the following :-

- The institutions shall maintain the teaching staff strength of 1:5 for the proposed D.Ed. course.
- The institutions shall note that with regard to NET / SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.7.2006.
- The institutions shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institutions shall within one month of the receipt of the Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an authorized official of the Regional Committee.
- That the Reserve fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the managements / institutions.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like IIGC and State Government etc.
