ORDER

WHEREAS, the institution, namely, **VIDYA PRATISHTHAN COLLEGE OF EDUCATION, MIDC, RESI-ZONE, BARAMATI-413133, DIST-PUNE, MAHARASHTRA** was granted recognition by WRC, NCTE for B.Ed. course vide order No.WRC/5-6/96/6365-6367 dated **23.11.1998** with an intake 160 students.

2. AND WHEREAS, permission was granted to the institution vide order No.WRC/2-32/58/2004/2390 dated 19.04.2004 for an additional intake of 40 students in B.Ed. course making the total intake of 200 students.

3. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No.WRC/OAPW0606/113116/2015/145506,509, 511,515,519,522,526,529 dated 31.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 150 students (three basic units of 50 students each) from the academic session 2015-2016.

4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on 01.03.2017.

5. AND WHEREAS, in response to the aforesaid show cause notice, reply submitted by the institution vide letter dated 22.03.2017 received in WRC on 27.03.2017.

6. AND WHEREAS, the matter was placed in the 287th meeting of WRC held on January 30 & 31, 2018, and the Committee has decided the following:-

"The case file was seen, In response to the Show Cause Notice dated 01.02.2017, the institution vide letter dated 22.03.2017 has submitted the building completion certificate from the Government Engineer certificate and staff profile of (1+11) faculty members, which is sufficient for only one unit.

However, the list is not approved by the Registrar and staff at S.no.12 does not have the required percentage at PG level. FDRs for Rs. 12.00 lakhs (in joint name) in original not submitted.


Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn".

7. AND WHEREAS, letter issued to the institution on 06.02.2018.

8. AND WHEREAS, in response to the aforesaid letter, reply submitted by the institution vide letter dated 22.02.2018 received in WRC on 01.03.2018.

9. AND WHEREAS, the institution vide letter dated 19.12.2018 received in WRC on 27.12.2018 has requested for closure of one unit in B.Ed. course.

10. AND WHEREAS, the matter was placed in 371st meeting held on September 21-22, 2022, and the Committee decided as under: -

"The original file of the Institution along-with other related documents were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Initial recognition was granted to B.Ed. course of one year dated 23.11.1998.
- Revised order was issued for B.Ed. course of two years dated 31.05.2015.
- In the matter of compliance of revised recognition in light of NCTE Regulations, 2014, 1st Show cause notice issued dated 01.03.2017.
- The institution is still deficient on the grounds of show cause notice.
- Latest approved faculty list issued by the affiliating body not submitted.
- Building completion certificate in the NCTE prescribed proforma has not been issued by Govt. engineer.
- The proposal submitted by institution on 19.12.2018 for reduction of B.Ed. intake from 100 (two units) to 50 (one basic unit).

In view of the above, the Committee decided as under:

(1) The institution be allowed permission for reduction of B.Ed. intake from 100 (two units) to 50 (one basic unit) w.e.f. the commencement of academic session 2022-2023. The Affiliating Body/State Government and others be intimated accordingly.

(2) Show Cause Notice be issued to the institution u/s 17 of the NCTE Act for B.Ed. programme to submit reply to SCN accompanied by an original affidavit within 30 days from the date of uploading of minutes on the website failing which the WRC will take decision as deemed fit as per the provisions contained in the NCTE Act and Regulations."

11. AND WHEREAS, the matter was again placed in 373rd WRC meeting held on October 8, 2022, and the Committee decided as under:-

"The decision taken by WRC as recorded at Sl.No.12 of minutes of 371st Meeting held on 21st & 22nd September, 2022 be modified and read as under:

The original file of the Institution along-with other related documents were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Initial recognition was granted to B.Ed. course of one year dated 23.11.1998.
- Revised order was issued for B.Ed. course of two years dated 31.05.2015.
- In the matter of compliance of revised recognition in light of NCTE Regulations, 2014, 1st Show cause notice issued dated 01.03.2017.
- The institution is still deficient on the grounds of show cause notice.
- Latest approved faculty list issued by the affiliating body not submitted.
- Building completion certificate in the NCTE prescribed proforma has not been issued by Govt. engineer.
- The proposal submitted by institution on 19.12.2018 for reduction of B.Ed. intake from 150 (three units) to 100 (two basic units).

In view of the above, the Committee decided as under:

(1) The institution be allowed permission for reduction of B.Ed. intake from 150 (three units) to 100 (two basic units) w.e.f. the commencement of academic session 2022-2023. The Affiliating Body/State Government and others be intimated accordingly.


(2) Show Cause Notice be issued to the institution u/s 17 of the NCTE Act for B.Ed. programme to submit reply accompanied by an original affidavit within 30 days from the date of uploading of minutes on the website failing which the WRC will take decision as deemed fit as per the provisions contained in the NCTE Act and Regulations."

12. **NOW THEREFORE, permission is hereby granted to Vidya Pratishthan College of Education, MIDC, Resi-Zone, Baramati-413133, Dist-Pune Maharashtra** for reduction of intake in B.Ed. course from an annual intake of 150 students (three units of 50 students each) to **100 students (two units of 50 students each).**

The terms and conditions mentioned in the revised recognition order issued vide order dated **31.05.2015** shall remain same.


