CONTINUED ORDER

WHEREAS, recognition was granted to the institution namely, VIDYAVATI COLLEGE, RUN BY - SMT. VIDHYAVATI MISHRA MEMORIAL PUBLIC TRUST, VIKRAMPURA, B.T.I. ROAD, BHIND-477001, MADHYA PRADESH under section 14(1) of the NCTE Act, 1993 for conducting B.Ed. course of annual intake of 100 (two basic Units of 50 students each) vide order No.APW00048/223114WRC/47/2003/11.02.2004 & APW06905/223114(Addl.) WRC/5-6/109th/2008/dated 04.11.2008 with (Addl.) annual intake of 100

AND WHEREAS, the revised recognition order was issued to VIDYAVATI COLLEGE, RUN BY - SMT. VIDHYAVATI MISHRA MEMORIAL PUBLIC TRUST, VIKRAMPURA, B.T.I. ROAD, BHIND-477001, MADHYA PRADESH vide order No. WRC/ APW00048/223114/APW06877/223114/Addl./2015 dt. 31.05.2015 for B.Ed. Programme of two years duration with an annual intake of 200 students (four basic units of 50 students each) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided "...issued Show Cause Notice to the institution has not submitted compliance of the condition maintained in revise order"

AND WHEREAS, a Show cause notice was issued to the institution on 12.05.2017 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order.

- 1) Original Staff Profile (1 Principal/HOD+15-Faculties) for the session 2015-2016 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

AND WHEREAS, the matter was placed in 268th Meeting held on February 09-11, 2017 and the Committee decided that... "The show Cause Notice was issued to the institutions as to why the number of units of the B.Ed. Course which were given by revised order, should not be reduced/reversed".

AND WHEREAS, Show Cause Notice was issued to the institution on 15.02.2017 and the reply was not submitted by the institution.

AND WHEREAS, the matter was placed in 310th Meeting held on August 19-21, 2019 and the Committee decided that... "The show Cause Notice was issued to the institution vide letter dated 15.02.2017. The summary of the case submitted reveals that the institution has not submitted reply on the show Cause Notice.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order"

AND WHEREAS, the Withdrawal order was issued to the institution on 05.09.2019.

AND WHEREAS, the appeal Authority order was issued to remands back dt. 02.03.2021

AND WHEREAS, the matter was placed in 316th Meeting held on August 27 to 28 & 04 September 2021 and the Committee decided that... "The Committee Considered the matter in view of the order of the Appellate Authority, Agenda Note. Court case and noted that the matter is sub-judice. The WRC decided that the matter be placed before WRC after final disposal by the Honble Court.

AND WHEREAS, the Hon'ble High Court of Delhi in Writ Petition (C) No. 5529/2020 Order dt.17.09.2020 has given an appropriate direction to WRC to issue the restoration order.

AND WHEREAS, the matter was considered by WRC in its **325th Meeting held on 09 January 2021** and WRC decided (Ref: Sl. No. 07, Page No. 05-06 of 325th WRC Minutes) as under: -

"As per direction of the Hon'ble High Court vide Order dated 17.09.2020 and, the original file of the Institution along with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-


The institution has submitted all required documents which were considered by the Committee and found fit the case for issuance of Recognition continuation order for four units of 50 students each.

In view of above, the Committee decided as under:

Recognition of the institution be continued for the B.Ed programme with an intake of four units of 50 students."

NOW THEREFORE, the recognition of **VIDYAVATI COLLEGE, RUN BY - SMT. VIDHYAVATI MISHRA MEMORIAL PUBLIC TRUST, VIKRAMPURA, B.T.I. ROAD, BHIND-477001, MADHYA PRADESH** for conducting B.Ed. course with an annual intake of 200 (four basic Units of 50 students each) is continued.
