Programme of two years duration with an annual crake of 200 students (four basic units of 50 students each) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 lun-, 2016 and the Committee decided "...issued Show Cause Notice to the institution has not submitted compliance of the condition maintained in revise order"

1) Original Staff Profile (1 Principal/HOD+15-Faculties) for the session 2015-2016 dury approved by the affiliating body.

2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

AND WHEREAS, the matter was placed in 268th Meeting held on February 05-1 2017 and the Committee decided that... "The show Cause Notice was issued to the institutions as to why the number of units of the B.Ed. Course which were given by revised order, should not be reduced reversed."

AND WHEREAS, Show Cause Notice was issued to the institution on 18.00.2011, and this reply was not submitted by the institution.

AND WHEREAS, the matter was placed in 310th Meeting held on August 19 21, 7019 and the Committee decided that... "The show Cause Notice was issued to the institution vide letter data 2017. ∃ ≘ summary of the case submitted reveals that the institution has not submitted reply and he now Cable Notice.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act 1993 for B.Ed. programme with effect from the end of the academic session most following to date of communication of the said order"
