RESTORATION ORDER

WHEREAS, the institution, namely, VIDYASAGAR COLLEGE, VILLAGE-BHICHOLI MARDANA, INDORE, MADHYA PRADESH was granted recognition by WRC NCTE for B.P.Ed. Course with an annual intake of 50 students vide order no. WRC/5-6/101ST/2008/C-28429-28435 dated 04.02.2008.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution WRC/APW05017/224143/Revised Order/{M.P}/2015/135286,87,89,90,91,92,94,95 dated 16.05.2015 for conducting B.P.Ed. course of two years duration with an annual intake of 100 students (one basic unit with two sections of 50 students each) from the academic session 2015-2016.

3. AND WHEREAS, the institution has not submitted compliance of revised recognition order dt. 16.05.2015.

4. AND WHEREAS, matter was considered by the WRC in its 255th meeting held on 22nd-24th June, 2016 and Committee decided to issue show cause notice to the institution. Accordingly, Show Cause Notice was issued dated 01.02.2017 and institution has submitted reply vide its letter dated 04.04.2017 received on 06.04.2017 wherein institution requested to shift its existing location to new location.


5. AND WHEREAS, matter was placed in 283rd meeting of WRC held on 14th-15th November, 2017 and Committee decided to issue Show Cause Notice on the following grounds:

- (a) Latest premium paid receipt of CLU.
- (b) Building Completion certificate approved from the Govt. Engineer; and
- (c) FDRs for Rs 12.00 Lakhs in joint name.

Accordingly, Show cause notice u/s 17 was issued to the institution dated 17.11.2017.

6. AND WHEREAS, reply vide letter dated 16.12.2017 from the institution in response to SCN received in this office on 19.12.2017, which was placed in 311th WRC meeting held on 25-27 September, 2019 and the Committee decided to withdraw the recognition for B.P.Ed. course with effect from the end of the academic session next following the date of communication of the said order. Accordingly, withdrawal order was issued to the institution dated 09.10.2019.

7. **AND WHEREAS**, being aggrieved, the institution filed an appeal and NCTE Appellate Authority vide order dated 19.03.2020 remanded back the case to WRC for revisiting the matter after receiving the required documents from the appellant institution.

8. **AND WHEREAS**, the institution filed W.P.(C) 5690/2020 in the Hon'ble High Court of Delhi at New Delhi and the Court has disposed of the case by passing an order dated 27.08.2020. The operative part of the order is as under:

“...7.... In these facts, the petitioner is permitted to join the counselling for the academic session 2020-21 subject to further orders of WRC.

8. The respondent shall forthwith take all consequential steps to allow the petitioner to participate in the present counselling including change of the status of the petitioner on their website and appropriate intimation to the affiliating University and to the Department of Higher Education, State of Madhya Pradesh.

9. WRC is free to decide the matter uninfluenced by any observations made by this court as per law and as per the directions of the Appellate Authority.”

9. **AND WHEREAS**, the matter was considered by WRC in its 316th meeting held on 27th-28th August, 2020 & 04 September, 2020 and the Committee decided that last opportunity be given to the institution to submit documents as directed by the Appellate Authority within 30 days u/s 17 of the NCTE Act for B.P.Ed. course. Accordingly, final Show Cause Notice was issued to the institution dated 21.09.2020.

10. **AND WHEREAS**, the institution W.P.(C) 7157/2021 in the Hon'ble High Court of Delhi at New Delhi and the Court has disposed of the case by passing an order dated 28.07.2021. The operative part of the order is as under:

“... 7... For the reasons aforesaid, it is directed that, for the academic year 2021-22 and subsequently, during the pendency of the remanded proceedings before the WRC until the passing of fresh withdrawal orders, if any, the institutions concerned will be entitled to participate in the counselling process and admit students. The NCTE is directed to restore the recognition of the petitioners by passing necessary orders to that effect within one week. It will also update its website to reflect this position and communicate the restored status of the petitioners to their respective affiliating universities and the concerned State Governments within one week from today.”

11. **AND WHEREAS**, the institution has submitted the reply of Show Cause Notice vide letter dated 18.04.2022 received on 05.05.2022 along with the court matter was placed in 370th meeting of WRC held on 10th & 12th September, 2022 and Committee decided as under:

“The original file of the Institution along-with other related documents, Order dated 28.07.2021 in W.P.(C) No. 7157/2021 passed by Hon'ble High Court of Delhi were



carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided that in compliance of direction of Hon'ble Court, recognition to B.P.Ed. course be restored until fresh withdrawal order is passed by WRC. The institution is permitted to participate in the counselling for admission to B.P.Ed. course for the academic session 2022-23 and subsequent academic sessions until a fresh withdrawal order is passed by WRC, being conducted by the Affiliating Body/concerned State Govt. The concerned State authorities be intimated accordingly. A copy of restoration order be also uploaded on the WRC web portal on NCTE website."

12. **NOW THEREFORE**, the recognition of the institution viz. VIDYASAGAR COLLEGE, VILLAGE-BHICHOLI MARDANA, INDORE, MADHYA PRADESH is hereby restored for the B.P.Ed. course with an intake of 100 students (one basic unit with two sections of 50 students each) as per above decisions of WRC until a fresh withdrawal order is passed by WRC, NCTE.

The terms and conditions shall remain same mentioned in the revised recognition order issued vide order no.135286 dated 16.05.2015.
