ORDER

WHEREAS, in terms of section 15 (3)(a) of the NCTE Act 1993, WRC had granted recognition to ADS GROUP OF COLLEGE, RUN BY- AJAR AMAR SHIKSHA SAMITI, KHASRA NO.113/1/2/7, VILLAGE TARA SEVANITYA, AIRPORT ROAD GANDHI NAGAR, BHOPAL, MADHYA PRADESH for D.El.Ed. course of two years duration vide order No. WRC/5-6/106th/2008/40019 dated 27.08.2008 with an annual intake of 50 students.

AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on 09.08.2015.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its 232nd Meeting held on September 16-17, 2015. The Committee decided as under:-
