## Withdrawal Order U/S-17

WHEREAS, recognition was granted to the institution, namely, DEVI RUKMANI MAHAVIDYALAYA, PANCHSHEEL COLONY, BISTAN ROAD, DISTRICT- KHARGONE, - 451001, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting **B.ED.** course vide order dated 26.09.2005.

- 2. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 23-01-2015.
- 3. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 28.05.2015.
- 4. AND, WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- 5. AND, WHEREAS, a Show cause notice was issued to the institution on 17.08.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:
  - 1) Staff Profile for the session 2015-16 duly approved by the affiliating body,
  - 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.
- 6. AND WHEREAS, the institution replied on 24.08.2016 & the matter was placed in 306<sup>th</sup> Meeting of WRC field on April 29<sup>th</sup> 30<sup>th</sup>, 2019 and the Committee decided that "... The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made:

The revised recognition order was issued to the institution on 28/05/2015. The Show Cause Notice was issued to the institution 17/08/2016. The institution has submitted reply of Show Cause Notice on 24/08/2016..

On perusal of the reply of the institution, it is observed that the institution has not submitted following documents:

- The institution has not submitted letter granting approval for the selection or appointment of faculty issued by the affiliating body as per NCTE Regulations 2014.
- The institution has not submitted original staff profile as per NCTE Amendment Regulations 2017.
- The institution has not submitted land use certificate issued by the competent authority.
- The institution has not submitted NEC issued by the competent authority.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

7. Hence, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition of the institution is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.
