Show Cause Notice

Whereas, in terms of Section 14 of the NCTE Act, 1993 **GYANVEER SEVA SAMITI, PLOT NO. - 30, 36/1, 37/1, MAIN ROAD JAISINAGAR, VILLAGE + P.O. + TEHSIL - JAISINAGAR, DIST. - SAGAR MADHYA PRADESH** had submitted the application on **29.12.2012** to Western Regional Committee of the NCTE for grant of recognition for starting the **B.ED. (CO-ED)**.

And Whereas, the application of the institution was processed and Hard copy received on **05.01.2013**.

And Whereas, the Clarification Letter issued to the Institution on **02.05.2013**.

And whereas, the reply received on **17.05.2013** was placed in **186th meeting held on 12-13 July, 2013** of WRC and Committee decided that "...An examination of the documents alongwith the information given in the online application, it is seen that under different college names, the Society is running more courses. So the total no. of seats is more than 300 which is against the clause 8(3) of NCTE Regulations, 2009. It is not clear from the files presented by the WRO whether these are different societies and different college names, or one Society with many colleges. Hence, it is necessary that WRO should process the present application after examining the old files in which the two B.Ed. of 100 each, two M.Ed. of 35 each, one D.El.Ed. of 50 each and one B.P.Ed. 50 were granted.

The land in both the cases is common."

And whereas, the **AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014** issued to the institution on **24.12.2014** and Still No reply had been submitted by the Institution.

And whereas the matter was placed in **223rd meeting held on April 23-24, 2015** of WRC and Committee decided that "...The institute has also not submitted the Affidavit for acceptance and compliance NCTE Regulations, 2014.

Hence, Show Cause Notice be issued on the above ground."

And Whereas, the Committee decided that before the Regional Committee passes an order of refusal, the institution may be given an opportunity for making such written representation as it may wish to make.

Now therefore, this Show Cause Notice is issued to the institution u/s 14 of NCTE, Act, 1993 giving an opportunity for making representation within a period of 30 days from the date of issue of this notice. In the event of this office not receive any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation and the Western Resional Committee shall take the decision, as it deems fit and proper.
