**WITHDRAWAL ORDER**

30/1/2011

WHEREAS, recognition / permission was granted to NAVEEN SWAMI VIVEKANAND B.ED. COLLEGE, BARKHEDI KALA, NEELBAD ROAD, BHOPAL, M.P. under section 14 (3)(a) of the National Council for Teacher Education Act 1993 for conducting B.ED. Course with an annual intake of 100 Seats from the academic session 2004-2005 vide WRC order No.WRC/5-6/52/2003/4520 dated 9/7/2004.

AND WHEREAS, the inspection of the institution was conducted on 03/8/2010 after consideration of the original file of the institution, VTR . and other relevant documents, in its 140 meeting held on 14-15 September 2010, the Western Regional Committee of National Council for Teacher Education (Here-in-after called "WRC") was satisfied that the institution had contravened the following provisions of the NCTE Act, Rules and Regulations, order framed there under;

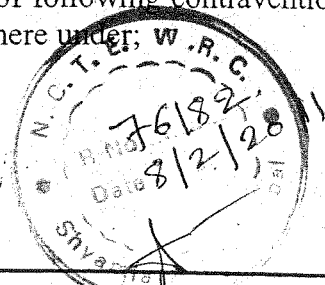
- (i) College does not exist on the land where it was permitted ( khasra no. 27, 63, 64/1/2) Village – Barikhedi Kalan.


AND WHEREAS, the WRC directed that an opportunity be given to the institution to make the written representation as to the aforesaid contraventions within a period of 30 days from the date of issue of the show cause notice before withdrawal of recognition / permission and issued the show cause notice dated 23/9/2010.

AND WHEREAS, the institution submitted the written representation dated 18/10/2010 which was considered by WRC in its 143 meeting held on 17-18 December 2010.

AND WHEREAS, the WRC considered the written representation of the institution in the light of VT report, video graph and other relevant documents on record. As regards contravention number (1), the institution stated that institution exists at land on khasra no. 146 and 147/1/1 of Barkhedi Kalan, Neelbad Road from its inception because institution has submitted land documents for land at khasra No. 27,63,64/1/3 registered with sub registrar office Bhopal on 6/9/2002 at time of submission of application for B.Ed. course.

NOW THEREFORE, the WRC, in exercise of its powers under section 17(1) of the NCTE Act, decided to withdraw the recognition / permission to the institution to conduct the B.Ed. course from the end of the academic session next following the date of communication of this order on account of following contraventions of the provisions of the NCTE Act, Rules and Regulations framed there under;





(i) **No building exists on the land specified by the institution at the time of application. The institution contravened the clause 7(d) of appendix 7 and (iv) of appendix 2 B of NCTE Regulations 2002.**

Affiliating body and the State Government are advised to cancel the affiliation of the institution under the provisions of section 17(3) of the NCTE Act and not to admit / allot students in the institution after the end of the academic session next following the date of this withdrawal order. In accordance with section 17(4) of the NCTE Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking the course or training in such institution, shall not be treated as valid qualification for purposes of employment under the Central Government, any State Government or University, or any school, college or other educational body owned or aided by the Central Government or any State Government.

Further, if the institution is not satisfied by this withdrawal order, it can prefer an appeal under section 18 of the NCTE Act to National Council for Teacher Education, Hans Bhawan, Wing II, 1 Bahadur Shah Zafar Marg, New Delhi 110 002, within 60 days from the date of this withdrawal order.
