Withdrawal Order U/S-17

WHEREAS, recognition was granted to the institution, namely, PRABHAT COLLEGE, PRABHAT PATTAN, B.L.P. COLONY, TEHSIL- MULTAI, DISTRICT.- BETUL, - 460665, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting **B.ED.** course vide order dated 28.08.2008.

2. AND WHEREAS, One Shri Pawan Dubey filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since the institutions are existing institutions, the inspection was conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

3. AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 18.12.2014.

4. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 21-01-2015.

5. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 26.05.2015.

6. AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

7. AND, WHEREAS, a Show cause notice was issued to the institution on 28.04.2017 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Original Staff Profile (1-Principal/HOD+ 15-Faculties) for the session 2015-16 duly approved by the affiliating body.
- 2) Originally notarized (not xerox) CLU, NEC, Building Plan and Building Completion Certificate in Prescribed format.

8. AND WHEREAS, the institution replied on 25.04.2019 & the matter was placed in 306th Meeting of WRC held on April 29th - 30th, 2019 and the Committee decided that "...The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made:

The revised recognition order was issued to the institution on 26/05/2015. The Show Cause Notice was issued to the institution 28/04/2017 with direction to submit the reply within 30 days.

- The institution has submitted reply dated 26/04/2019 to the Show Cause Notice dated 28/04/2017 but the reply is not within the period prescribed in the Show Cause Notice.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

9. Hence, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition of the institution is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.

10. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 **online** against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.


