And whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.

- And whereas, the institution by a notarized affidavit dt. 27.01.2015 consented to come under new Regulations and 2. sought for one basic unit (50 students) of two years M.Ed. course which required additional facilities.
- And whereas, it was decided to permit the institution to have one unit(s) of 50 students, subject to the institution 3. fulfilling following conditions, namely:
- The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31st, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31st, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting team at the time of inspection.

In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

- 2. And whereas, the C.M.D Post Graduate College, Run By- C.M.D Education Society, C.M.S P/G College, Link Road, Plot No. Khasra No. 558/1, Juna Bilaspur, Chattisgarh- 495001 by affidavit dt. 27.01.2015 has consented to come under new Regulations and sought for One basic unit in **M.Ed.** which require additional facilities
