Whereas, recognition was granted to the institution, namely, Shri B.D. Shah College of Teacher Education, Modasa, Sabarkantha, Gujarat, for conducting B.Ed. course of one year duration vide order No. WRC/5-6/21/2000/8353-58 dated :10.10.2000 with an intake of 90 students,

And, whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.

2. And, whereas, the institution by a notarized affidavit dt 13.01.2015 consented to come under new Regulations and sought for two units of two years B.Ed. course which required additional facilities.

3. And, whereas, it was decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions, namely:

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31st, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31st, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by October 31st, 2015. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. And, whereas, in light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) issued the revised recognition order to Shri B.D. Shah College of Teacher Education, Modasa, Sabarkantha, Gujarat for conducting B.Ed. course of two years duration subject with an annual intake of 50 students (one basic unit of 50 students) from the academic session 2015-16 subject to fulfillment of the above conditions.

And, whereas, the date for compliance regarding faculty was extended by the NCTE Hqrs. upto 29th February, 2016 and for additional built up area and addl. FDRs in the joint name, upto 30th May, 2016.

2. Originally notarized CLU, (Certificate for Land Use), Non-Encumbrance Certificate, Approved Building Plan and, Building Completion Certificate issued by Engineer of Rural Engineering Service or PWD Engineer.

In compliance of the decision of the WRC, the Show Cause Notice is issued to the institution under Section 17(1) of the NCTE Act, 1993. The institution is directed to submit written representation within a period of 21 days from the date of this Notice. In the event, this office does not receive any reply, it will be presumed that the institution has nothing to say and the Regional Committee shall take action for withdrawal of recognition.

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And Whereas, The B.D. Shah College Of Education College Of Teacher Education (C.T.E.) Run By The M.L.Gandhi Higher Education Society-Modasa, Sabarkantha-383315 Gujarat By affidavit dt.13.01.2015 has consented to come under new Regulations and sought for one basic units in B.Ed, which require additional facilities

5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmers along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

8. Recognition order no. WRC/5-6/21/2000/8353-58 dt. 10.10.2000 be treated as cancelled from the date of issue of this revised order.

9. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. 

- Endowment fund as per NCTE norms to be deposited in the name of B.D. Shah College of Education.

The institution is advised to send a compliance report upto 31 December, 97 as to the removal of deficiencies so that a new team may be sent to verify the same. The first priority should be given to the appointment of staff to bring the staff student ratio to 1:10. For 100 students 10 teaching staff members are needed apart from the principal. In case the institution does not appoint additional staff, the number of students to be admitted will be reduced from the next session in accordance with the student-staff ratio laid down by the NCTE, provided the institution is permitted to continue for the session 1998-99.
