Whereas, the WRC had granted the recognition to Anand College of Education, Run by Shri Ramkrishna Seva Mandal Managed, Near Electric Grid, Anand, Gujarat - 388001 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/44/2003/2507-2512 dt. 29.03.2005.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Anand College of Education, Run by Shri Ramkrishna Seva Mandal Managed, Near Electric Grid, Anand, Gujarat - 388001 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 05.01.2015 from the institution, a revised recognition order no. WRC/323025/2015/141034 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 50 seats (one basic unit of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014 :-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.

2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.

3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255th meeting held on June 22nd -24th, 2016 to verify the compliance of NCTE Regulations, 2014 and the Committee decided to issue show cause notice dt. 12.08.2016

And whereas, reply dt. 27.08.2016 was placed before the WRC in its 283rd meeting held on November 14th – 15th, 2017 and the Committee decided as follows :-

"The case file was seen. As per Revised Recognition order, the institution has submitted documents as required. However, the staff profile approved by the affiliating body should be submitted in original. It is also noticed that Principal has not been appointed and there are only five faculty members, as against requirement of 1+7.

Secondly, additional FDR towards Reserve Fund of Rs.4.00 lakhs (in joint name) and Building Completion Certificate signed by a Govt. Engineer should be submitted in original.

Compliance should be submitted by the institution within one month, failing which action will be initiated as per NCTE Regulations, 2014."

Accordingly, WRC vide letter dt. 17.11.2017 was issued to the institution.

And whereas, reply dt. 07.12.2017 was placed before the WRC in its 292nd meeting held on May 15th - 17th, 2018 and the Committee decided as follows :-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 12.08.2016 followed by a compliance letter dated 17.11.2017 were issued.

The institution vide reply dated 07.12.2017 has not submitted the required documents.

Hence, Recognition is withdrawn from the next academic session 2018-2019..

Now, therefore, the recognition of Anand College of Education, Run by Shri Ramkrishna Seva Mandal Managed, Near Electric Grid, Anand, Gujarat - 388001 for conducting B.Ed. programme of two years duration with an annual intake of 50 seats (one basic units of 50 students), is hereby withdrawn from the academic session 2019-2020 in terms of Section 17(1) of the NCTE Act,

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi – 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
