Withdrawal Order

Whereas, the recognition was granted to the institution namely SHALIN P.T.C. COLLEGE, NEAR SEEMA HALL, 100 ROAD, SATELITE, OPP. VRAJDHAM, AHMEDABAD, GUJARAT (APW02573/322282/323197) for P.T.C. Course vide order No. WRC/5-6/89/2006/ dated 27-09-2006 in a rented premises (as per record) for a period of 3 years as per the provisions contained under the Regulations 2002.

And whereas, Show Cause Notice under section 17 of the NCTE Act, 1993 was issued to the institution on 23.04.2012 inter-alia informing them about the provision of the regulations and compliance of shifting of the institution in its own premises from the rented premises where the recognition was granted.

And whereas, the institution did not submit any reply in compliance of the show cause notice dated 23.04.2012 even after expiry of the time limit mentioned there.

And whereas, the matter was placed before WRC in its 167^{th} Meeting held on $24^{th}-26^{th}$, July 2012, and the Committee considered the whole issue in detail and arrived at the conclusion that the institution is breaching the provisions under which recognition order issued to it vide No. WRC/5-6/89/2006/ dated 27-09-2006 for P.T.C. course for an intake of 50 seats and therefore, it was decide to withdraw the recognition on the following reasons:

No reply has been received from the institution.

Now therefore, in exercise of powers vested under section 17(1) of the NCTE Act, 1993, the recognition of SHALIN P.T.C. COLLEGE, NEAR SEEMA HALL, 100 ROAD, SATELITE, OPP. VRAJDHAM, AHMEDABAD, GUJARAT for P.T.C. course is here by withdrawn from the academic session 2013-2014.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, I, Bahadur Shaḥ Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act. 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
