- The institution shall within one month of the receipt of recognition create an endowment fund account into a (c) joint account to be operated along with an official of the Regional Committee.
- The institution shall shift to its own premises within three years from the date of recognition (In case the (d) course is started in rented premises).
- The institution shall comply with the various other norms and standards as prescribed in the NCTI (e) Regulations. PTC
