Recognition Order

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 SHREEMATI CHANDRIKABEN A.K. PATEL WOMENS PTC COLLE, GNANYOG EDUCATION AND WELFARE, TRUST, 10, SHANTINATH SOCIETY, AT & PO. PRANTIJ, JUNABAKARPUR, SABARKANTHA-383205, GUJARAT has submitted an application (Code No.- APW02531/322281) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting P.T.C. course with an annual intake of 50 students on 20-Dec-05. NCTE, WRC vide its letter No.WRC/5-6/E-87/2006/797 dt. 31.08.2006 granted recognition to PTC course with an annual intake of 50 students from effect of 2006-2007.

- 2. AND WHEREAS in its 119TM meeting held on May 27-28, 2009 the Western Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to withdraw recognition u/s 17 of NCTE Act of the institution for P.T.C. course and accordingly the withdraw/order No. WRC/APW02531/322281/323203/WRC/119/2009 dated 08.06.2009 was issued to the institution.
- 3. AND WHEREAS the correspondent, SHREEMATI CHANDRIKABEN A.K. PATEL WOMENS PTC COLLE, GNANYOG EDUCATION AND WELFARE, TRUST, 10, SHANTINATH SOCIETY, AT & PO. PRANTIJ, JUNABAKARPUR, SABARKANTHA-383205, GUJARAT, has preferred an appeal to NCTE New Delhi against the decision of WRC refusing recognition under section 18 of the NCTE Act, 1993 against the said Order.
- 4. AND WHEREAS having considered the oral submission by the representative of the institution, the written representation, the record of the case and V.T. Report, the Appellate Authority decided to reverse the order of NCTE, WRC. Accordingly, the appeal was accepted with direction to WRC to grant recognition to the institution immediately.
- 5. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993 and as per the NCTE, New Delhi Order No. F.No.89-591/2009/Apeeal/100045 dated 07.08.2009 the Western Regional Committee hereby grants recognition to SHREEMATI CHANDRIKABEN A.K. PATEL WOMENS PTC COLLE, GNANYOG EDUCATION AND WELFARE, TRUST, 10, SHANTINATH SOCIETY, AT & PO. PRANTIJ, JUNABAKARPUR, SABARKANTHA-383205, GUJARAT. for conducting P.T.C. course of ELE of 2 year duration with an annual intake of 50(ELE) under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulation 2007 from academic session 2009-2010.
- 6. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.
- 7. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 8. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
- 9. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

- 10. Further, subject to the provision of NCTE Act 1993, the institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, applicable.
- 11. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as well as the control of following as mandatory disclosure:
 - (i) Copy of the Application Form
 - (ii) Land and Building Particulars.
 - Staff Profile. (iii)
 - (iv) Recognition letter.
 - Information for having fulfilled the norms & standard and other required conditions. (v)
- 13. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
- 14. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi- 110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
