The institutions intending to run the teachers training programme approved above in a (h) rented premises are required to submit report in compliance of the requirement of NCTE (i) Regulations on the subject regarding their shift to permanent building.

- If any of the institutions contravene any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and / or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act 1993. The NCTE Hqrs. May also cause inspections under Section 13 of NCTE Act, 1993.
- It is mandatory for the institutions to complete 180 teaching days as such the concerned 6. university/board should ensure the recognition granted as per NCTE regulations and if the recognition date did not match with the academic calendar then the recognition granted shall be effective from the ensuing academic session...
