Withdrawal Order

Whereas, the recognition was granted to the institution namely PRARTHANA PRIMARY TEACHERS TRAINING COLLEGE, VIVEKANAND EDUCATION TRUST, PRANAM SHIKSHAN SANKUL, KANETI ROAD, AT.SANAD, TA. SANAD, AHMEDABAD-382110, GUJARAT (APW04078/322410) for P.T.C.(CO.ED.)(GUJARATI) Course vide order No.WRC/5-6/99th/2007/C-20130-20137 dated 25-07-2007 in a rented premises (as per record).

And whereas, a Show Cause Notice under section 17 of the NCTE Act, 1993 was issued to the institution on 24.01.2012 inter-alia informing the institution about the provision of the regulations and compliance of shifting of the institution in its own premises from the rented premises where the recognition was granted.

And whereas, the institution did not submit reply in compliance of the show cause notice dated 24.01.2012 even after expiry of the time limit mentioned therein.

And whereas, the matter was placed before the WRC in its 174th Meeting held on 19th - 21st, Nov. 2012, and the Committee decided to withdraw the recognition on the following grounds :-

- A show cause notice was sent to the institution on 24.01.2012 to which no reply has been received till date. Hence Recognition is Withdrawn from the end of the academic session next following the date of the withdrawal order.

Now therefore, in exercise of powers vested under section 17(1) of the NCTE Act, 1993, the recognition of PRARTHANA PRIMARY TEACHERS TRAINING COLLEGE, VIVEKANAND EDUCATION TRUST, PRANAM SHIKSHAN SANKUL, KANETI ROAD, AT.SANAD, TA. SANAD, AHMEDABAD-382110, GUJARAT for P.T.C.(CO.ED.)(GUJARATI) course is hereby withdrawn from the end of the academic session next following the date of the withdrawal order.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
