

WHEREAS in terms of Section 14(1)/Section 15(1) of the NCTE Act, 1993 SMT. MANJULABEN V. PATEL COLLEGE OF P.T.C., AT AHEWA, AT POST KANGAVI, TAL. DHARMPUR, DIST.
