## ORDER

WHEREAS Recognition/Permission was granted to the institute VIDYANAGAR P.T.C. COLLEGE, SURJIT SOCIETY, TB. ROAD, BAPUNAGAR, AHMEDABAD-380024, GUJARAT under section 14 of NCTE Act, 1993 for conducting P.T.C (CO-ED)(GUJ) course with an intake of 100 from the academic session 2008-2009; vide order No.WRC/APW05577/322256 (ADDL.)/WRC/5-6/107/2008/43622 dated 18.09.2008.

- WHEREAS on the basis of complaint received against institution, the Western Regional Committee had constituted a Visiting Team u/s 17 of NCTE Act, 1993 to visit the institution.
- AND WHEREAS, THE inspection of the institution was conducted on 11.01.2009 3.
- AND WHEREAS, the matter was considered by the WRC in its 114th meeting of WRC hereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms:-
- 1. Approved building plan submitted in all files Code No. 322282, 323197, 322256, 323544, 325096 are same.
- 2. Land area inadequate.
- 3. Building area inadequate.
- 4. All laboratories are having inadequate facilities.
- 5. Library facilities are inadequate.
- 6. College has tried to mislead NCTE by providing misleading address.
- AND WHEREAS the WRC directed that an opportunity be given the institution to make a written representation within 30 days from the date of the letter before withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a show cause notice was issued to the institution on 22.02.2009.
- AND WHEREAS the matter was again considered by the Committee in its 117TH meeting held on April 20-21, 2009 and having taken into consideration all the relevant facts of the case, it was decided to withdrawn recognition for conducting P.T.C (CO-ED) (GUJ) course from the academic session 2009-2010
- Now, therefore recognition to VIDYANAGAR P.T.C. COLLEGE, SURJIT SOCIETY, TB. ROAD, BAPUNAGAR, AHMEDABAD-380024, GUJARAT in terms of section 17(1) of the NCTE Act, 1993 is hereby withdrawn from academic session 2009-2010 on the following grounds.
- Built-up area is insufficient to run this course. 1.
- Affiliating Body/ State Govt. are advises not to admit/ allot any student in P.T.C (CO-ED) (GUJ). in the said institute. In accordance to the section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposed of employment under the Center Government, any State Government or University, or in ant school, college or other educational body aided by the Central Government or 412. 21m any State Government.
