WHEREAS recognition was granted to the institute namely SMT. K.B. DAVE ADHYAPAN MANDIR, I SHREE KAMLA SEVA TRUST 1, RAM NAGAR SOCIETY, OPP. RAGHA GAS AGENCY, AT/PO. VIJAPUR MEHSANA 382870 GUJARAT under section 14 of NCTE Act, 1993 for conducting PTC course vide order No.WRC/2-32/61 (SCM)/2004/4634 dt. 15/7/2004, No.WRC/2-32/322165/76/2005/6751 dt. 20/8/2005 and No.WRC/5-6/88/2006 dt. 15/9/2006.

- WHEREAS the recognition of the institution has been withdrawn by WRC, NCTE vide letter No.WRC/322165/121st/2009/57917-57923 dt.23.07.2009.
- AND WHEREAS, the institution preferred appeal before the council against the order u/s 18 of NCTE Act. 1993.
- AND WHEREAS, New Delhi vide its order F.No. 89-1092/2009-Appeal/A 7072 dt. 26.11.2009 remand back the case for re-issuance of show cause notice pointing out the deficiencies, mentioned in the report of state government and there after passed appropriate order.
- AND WHEREAS, WRC, NCTE, vide its letter No. F.No.WRC/322165th/2010/63123 dt. 12/01/2010 reissued show cause notice with the copy of compliant received from Principal/Secretary, Education Department of the State Government of Gujarat giving an opportunity to the institution to make a written representation within 15 days from the date of issue of notice before withdrawal of recognition as per provision contained under section 17 of the NCTE Act.
- AND WHEREAS, the matter was again considered by the Committee in its 132nd meeting held on March 19-20, 2010 and having taken into consideration the reply submitted by the institution and all the relevant facts of the case, it was decided to withdrawn recognition for conducting P.T.C. course on the following grounds-
- Staff not qualified as per NCTE norms. 1.
- Now, therefore, in exercise the power vested under section 17 of NCTE Act, 1993 the Western Regional Committee herby withdrawn above recognition granted to SMT. K.B. DAVE ADHYAPAN MANDIR, I SHREE KAMLA SEVA TRUST 1, RAM NAGAR SOCIETY, OPP. RAGHA GAS AGENCY, AT/PO. VIJAPUR MEHSANA 382870 GUJARAT from the end of the academic session next to the following date of this withdrawal order on the above grounds.
- Affiliating Body/ State Govt. are advises not to admit/ allot any student in P.T.C. in the said institute. In accordance to the section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposed of employment under the Center Government, any State Government or University, or in ant school, college or other educational body aided by the Central Government or any State Government.
