WHEREAS in terms of Section 14(3) (a) & 15 3(a) of the NCTE Act, 1993, recognition was granted to SMT. K.B. DAVE ADHYAPAN MANDIR, SHREE KAMLA SEVA TRUST 1, RAM NAGAR SOCIETY, OPP. RAGHA GAS AGENCY, AT/PO-VIJAPUR MEHSANA-382870, GUJARAT for conducting P.T.C. course vide order No. WRC/2-32/61(SCM)/2004/4634 dt.15.07.2004 (50 seats), order No. WRC/2-32/322165/76/2005/6751 dt. 20.08.2005 (additional 50 seats) and No. WRC/5-6/88/2006 dt.15.09.2006 (additional 50 seats).

- AND WHEREAS in its 132nd meeting held on March, 19-20, 2010, the Western Regional Committee 2. after considering the report of the visiting team as well as other relevant material furnished by the applicant institution decided to withdrawn the recognition on the said institution for P.T.C course under section 17 (1) of NCTE Act, 1993 and accordingly the withdrawn order No. WRC/ 322165/132/2009/66338-66344 dated 26.03.2010 was issued to the institution.
- AND WAHEREAS the correspondent, SMT. K.B. DAVE ADHYAPAN MANDIR, SHREE KAMLA SEVA TRUST 1, RAM NAGAR SOCIETY, OPP. RAGHA GAS AGENCY, AT/PO-VIJAPUR MEHSANA-382870, GUJARAT had preferred an appeal to Council (NCTE), New Delhi under section 18 of the NCTE Act, 1993 against the said withdrawn order dated 26.03.2010.
- 4. AND WHEREAS Council (NCTE), New Delhi, passed an order No F.No.89-331/2010-Appeal dated 9.06.2010 in the appeal filed by the institution and Counsel set aside WRC's order dated 26.03.2010 and remand back the case to WRC for re-examination of the reply submitted by the institution, in reference to the deficiencies pertaining to NCTE Norms and standards and regulation only and for issusing a speaking order therefore. accordingly case was remanded to the WRC.
- AND WHEREAS, in compliance of order No F.No.89-331/2010-Appeal dated 9.06.2010 passed by the Councel (NCTE) New Delhi, the case was re-examined by the WRC and WRC noted that the institution was recognized for three units of PTC course (150 seats). As per list of teaching staff provided by the institution the institution has two Principal and 49 Lecturers, but only two Principal and seven lecturer are having qualification
