WITHDRAWAL ORDER

WHEREAS, WRC-NCTE had granted permission to the institution namely VISHAVA BHARTI MANDAL -VIJAPUR PTC COLLEGE, 28 AMIKUNJ, BEHIND PASHABHAI PETROL, PUMP, AT-P.O.-NAGALPUR, TAH.- MEHSANA, MEHSANA GUJARAT-384002 vide order No. WRC/ 5-6/88 /2006 dated 15.09.2006 for conducting P.T.C. course with an annual intake of 50 students in a rented premises with a condition to shift to its own premises within three years of such recognition.

2. The matter was considered by WRC in its 316^{th} meeting of WRC held on 27^{th} – 28^{th} and 4^{TH} August 2020 wherein the committee decided as under: –

The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision.

- 3. Accordingly, the Show Cause Notice was issued to the institution vide dated 28.09.2020, and the institution has not submitted the reply of the above Show Cause Notice.
- 4. AND WHEREAS, the matter was considered by WRC in its 321st meeting of WRC held on 09th to 11th November 2020, wherein the committee decided as under: -

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. Recognition was granted to the institution on 15.09.2006 on rented premises with a condition that to shift the institution in its own

2. The institution has not shifted the institution in its own premises till

- 3. Accordingly, Show Cause Noted was issued to the institution on 28.09.2020.
- 4. The institution has not submitted the reply of the Show Cause Notice till date.

In view of above, the Committee decided that the recognition of D.El.Ed programme of the institution be WITHDRAWN under clause 7(15) from the next academic session 2021-22."

- NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE 6. Act, 1993, the Western Regional Committee hereby withdraws recognition of VISHAVA BHARTI MANDAL -VIJAPUR PTC COLLEGE, 28 AMIKUNJ, BEHIND PASHABHAI PETROL, PUMP, AT-P.O.-NAGALPUR, TAH.- MEHSANA, MEHSANA GUJARAT-384002 for P.T.C.course on the grounds mentioned above from the end of the academic session next following the date of communication of the said order.
- Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.
