

The institute concerned shall send a report in this regard to WRC of NCTE within 30 days, in terms of clause 7 (12) of the NCTE Regulations 2005.
- The institutions shall note that with regard to NET / SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.7.2006.
