RESTORATION ORDER

WHEREAS, recognition was granted for B.Ed. programme of one year duration with annual intake of 100 students to the institution namely B.Ed. College, Shree Arvalli Sadbhavna Charitable Trust, At. Po. & Ta. – Vijaynagar, Sabarkantha, Gujarat – 383460 vide Order No.WRC/2-32/323194/73/2005/4813 dated 24.06.2005.

- 2. **AND WHEREAS,** after promulgation of NCTE Regulations, 2014, Revised Recognition Order was issued for B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016 to the institution namely B.Ed. College, Shree Arvalli Sadbhavna Charitable Trust, At. Po. & Ta. Vijaynagar, Sabarkantha, Gujarat 383460 vide F.No.WRC/APW01111/323194/2015/145732,736,742,749,753,757,761,765 dated 31.05.2015.
- 3. **AND WHEREAS**, the institution did not submit compliance of conditions mentioned in the Revised Recognition Order dated 31.05.2015.
- 4. **AND WHEREAS**, the institution has submitted request vide letter No. 27/2015-16 dtd. 30.10.2015 regarding reduction of B.Ed. intake from two units to one unit.
- 5. **AND WHEREAS**, matter was considered by WRC in its 277th WRC meeting held on 29th 30th June, 2017 and as decided by the Committee, Show Cause Notice u/S was issued dated 05.07.2017 to the institution.
- 6. **AND WHEREAS,** reply in response to Show Cause Notice submitted by institution vide letters No.028/2017 -18 dated 07.08.2017 & 19.02.2018 was considered by WRC in its 304th meeting held on 02nd 04th April, 2019 and as decided by the Committee last opportunity was given to the institution vide letter dated 12.04.2019 with direction to submit the letter of approval of faculty of affiliating body along with detailed staff profile approved by competent authority of the university within 30 days, failing which recognition will be withdrawn under Section 17 of NCTE Act, 1993.
- 7. **AND WHEREAS**, the institution submitted reply vide letter dated 01.08.2019 received on 05.08.2019 together with approved staff profile and copies of FDRs of Rs. 5 & 3 lakhs (not eligible) and another University's letter No. Aca/Recog./10210/2022 dtd. 26.05.2022, together with staff profile of only 5 faculty/ies and 02 Nos are not eligible.
- 8. **AND WHEREAS,** almost after a gap of 05 years, the University namely "Hemchandracharya North Gujarat University" has sent a letter vide No.Aca/Recog./4543/2024 dtd. 22.11.2024 received on 05.12.2024, which was analysed by the office of WRC.
- 9. **AND WHEREAS**, matter was considered by WRC in its 413th WRC meeting held on 27th 29th January, 2025, wherein Committee decided as under:

"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decides as under:

Show Cause Notice was issued to the institution on 05.07.2017 followed by final show cause Notice dated 12.04.2019 and the institution has submitted reply of Final SCN which was received in WRC office on 05.08.2019. After considering the reply submitted by the institution, the Committee observed as under:

- Principal is not appointed on regular basis and appointed as in-charge.
- Appointed Principal and faculties are not eligible as per provision of Clause-5 of Appendix-4 of NCTE Regulations, 2014 & GoI. No. 237 dated 09.06.2017.
- Faculty is not as per provision of Clause-5 of Appendix-4 of NCTE Regulations, 2014 & GoI. No. 237 dated 09.06.2017.

In view of the above, the Committee decided that recognition granted to B.Ed. course be withdrawn u/S-17 of NCTE Act, 1993 from the academic session next following the date of issue of withdrawal order with a copy to State Government, Affiliating Body and all concerned."

Accordingly, as decided by WRC, withdrawal order dated 18.03.2025 was issued to the institution with copy endorsed to all concerned mentioned therein.

- 10. **AND WHEREAS**, the institution filed an Appeal against the Withdrawal Order dated 18.03.2025 and Appellate Authority, NCTE passed an Order dated 09.07.2025 rejecting the appeal and confirming the withdrawal order of WRC.
- 11. **AND WHEREAS,** institution filed writ petition W.P.(C) 10920/2025 before the Hon'ble High Court of Delhi and the matter was considered by WRC in its 432nd (Part-I) Meeting held on 06th 08th August, 2025 along with court order dated 28.07.2025, the application of the institution, other related documents in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

"The Hon'ble High Court of Delhi has passed Order dated 28.07.2025 in W.P.(C) 10920/2025 with following directions, the operative part of court order is as under:

- "... 6, In view of the above, the interest of justice would be subserved if the present petition is disposed of by setting aside the impugned withdrawal order dated 18.03.2025 passed by WRC as well as order dated 09.07.2025 passed by the Appellate Authority of NCTE with a direction to WRC to reconsider the matter. Ordered accordingly.
- 7. Consequently, respondent/NCTE is directed the issue restoration of recognition of petitioners. Petitioners institute will be permitted to participate in counseling and admit students for the academic year 2025-2026 and also for subsequent academic years until and unless a fresh withdrawal order is passed against it.

8. The status of petitioner as a recognized institution will also be reflected on the

respondent/NCTE's website and will be communicated by the respondent/NCTE to petitioner, affiliating University as well as to the concerned Department of the State Government.

- 9. Respondents are directed to comply with these directions within period of 10 days.
- 10. The petition stands disposed of in above terms."

In view of the above, the Committee decided that in pursuance of above directions issued vide order dated 28.07.2025 of Hon'ble High Court of Delhi, the WRC in its 432nd (Part-I) meeting held on 6th-8th August, 2025 decided that recognition for B.Ed. course with annual intake of 100 is restored with a copy endorsed to institution and all concerned and status of institution as recognized be reflected on the NCTE website."

- 12. NOW THEREFORE, in compliance of directions of Hon'ble Court, recognition for B.Ed. programme with an annual intake of 100 students (two basic units of 50 students each) in respect of institution viz. B.Ed. College, Shree Arvalli Sadbhavna Charitable Trust, At. Po. & Ta. Vijaynagar, Sabarkantha, Gujarat 383460 is hereby restored.
- 13. The terms and conditions shall remain same as mentioned in the revised recognition order issued vide order dated 31.05.2015.
