And whereas, reply dt. 07.08.2013 & received on 16.08.2013 submitted by institution was placed in 190<sup>th</sup> meeting of WRC and committee decided to issued Clarification to the institution on 21.10.2013.

And whereas, reply of Clarification on dt. 07.11.2013 and the matter was placed in 195<sup>th</sup> meeting of WRC and committee decided to the recognition is restored.
