WHEREAS, recognition was granted to the institution SARASWATI P.T.C. COLLEGE MANAGED BY, SMT. D.A. PUROHIT EDUCATION TRUST AT-GHADI, POST -GHADI, TA. PRANTIJ, SABARKANTHA GUJARAT, under Section 14 of NCTE Act, 1993 for conducting PTC Course with an intake of 50 students vide order No. WRC/5-6/88th/2006/ dt.15.09.2006.

- And whereas. the recognition
- was withdrawn vide WRC/APW02521/322280/127<sup>th</sup>/2009/53' ,-5361 dt. 29.10.2009 as per decision of 127<sup>th</sup> meeting of WRC
- And whereas, the matter was considered by WRC in its 145th meeting in the light of the direction of the Hon'ble High Court of Gujarat at Ahmedabad in ECA No 3205/2009and related matters and decided to cause inspection. The inspection of the institution was conducted on 19.04.2011 The VT report was placed in 150th meeting of WRC and the Committee noted that the following deficiencies exist vis-a-vis NCTE norms:-.

Staff list duly approved by the examining body not submitted.

- 2. The land documents duly certified by the competent authority was not submitted along with the application that was required as per the section 7(d) of NCTE Norms and Standards 2002 or as Section 8(5) of NCTE Norms and Standards 2005.
- And whereas the Show caus notice was issued to the institution vide letter No. WRC/APW02521/322280/150/2011/79096 ut. 21.06.2011.
- AND WHEREAS, the reply submitted by the institution was considered by the WRC Committee in its 153<sup>rd</sup> meeting held on 28<sup>th</sup>-30<sup>th</sup>, July, 2011 and having taken into consideration all the relevant facts of the case, it was decided to withdraw recognition for conducting B.ED Course from the end of the academic session next following the date of this withdrawal order.
- 6. Now, therefore, recognition to SARASWATI P.T.C. COLLEGE MANAGED BY, SMT. D.A. PUROHIT EDUCATION TRUST AT-GHADI, POST-GHADI, TA. PRANTIJ, SABARKANTHA GUJARAT for the B.ED course in terms of Section 17(1) of the NCTE Act. 1993 is hereby withdrawn from the end of the academic session next following the date of this withdrawal order on the following grounds:-

### 1. Lecturers in Music / Arts and Physical Education are not appointed.

The affiliating body/State Govt. are advised not to admit/allot any student to SARASWATI P.T.C. COLLEGE MANAGED BY, SMT. D.A. PUROHIT EDUCATION TRUST AT-GHADI, POST -GHADI, TA. PRANTIJ, SABARKANTHA GUJARAT. As per Ecction 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Gdvernment.
