The matter was considered by WRC in its 172nd meeting held on October 13-15, 2012 wherein Committee decided that recognition granted to Shri Amar Jyot Education Trust, Himmat Vidyanagar, Kandla Highway, Radhanpur, Patan, Gujarat-385340 vide order No.WRC/2-32/322169/74/2005/5022 dated 27.06.2005 for an additional intake of 50 & vide Order No.WRC/5-6/92th (Ext.)/2007/C-21492 dated 07.08.2007 for an another additional intake of 50 were withdrawn vide order dated 08.11.2012.
- , 5. **AND WHEREAS**, vide letter dated 22.02.2019, 04.03.2022, 21.09.2022, the institution has requested for permanent closure of P.T.C. course and return of FDRs.
- **AND WHEREAS**, the matter was considered by WRC in its 375th meeting of WRC held on November 18-19, 2022, and the Committee decided as under:-

"The original file of the Institution along-with other related documents, were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Recognition was granted for P.T.C. course vide order dated 24.08.2004 followed by order dated 27.06.2005 and 07.08.2007 for enhancement of intake.
- Order issued for enhancement of intake has been withdrawn vide order dated 08.11.2012.
- Performance Appraisal Report for the academic session 2020-2021 not submitted.
- The institution informed vide letters dated 22.02.2019, 04.03.2022 and 21.09.2022 requesting for closure of PTC course and return of FDRs.
- Copy of resolution of the society dated 10.12.2017 to this effect submitted by the institution.
