Recognition Order

Whereas, in terms of Section 14(1) of the NCTE Act, 1993, DINTRICT INSTITUTE OF EDUCATION AND TRAINING, PLOT NO. 3410, ROAD - RGT CAMPUS, DIST - PORBANDAR -360575, GUJARAT, (Code No. WRCAPP1519) had submitted an application on 07,10,2011 to the Western Regional Committee of the NCTE for grant of recognition of D.E.L.Ed./P.T.C. course with an annual intake of 50 seats.

And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution has adequate financial resources, accommodation, library, laboratory and that it fulfills such other conditions required for proper functioning of the institution for D.EL.Ed./P.T.C. course, as determined by clause 7(9) of NCTE Regulations, 2009, and decided to issue letter of intent dt. 30.07.2012.

And whereas, reply dt. 28.05.2013 submitted by the institution was considered by WKC in its 1907th meeting and committee is satisfied that the institution has adequate financial resources, accommodation, library, qualified stair, laboratory and that it fulfills such other conditions required for proper functioning of the institution for D.EL.Ed./P.T.C. course, as determined by NCTE Regulations 2009.

Now, therefore, in exercise of the powers vested under Section 14 (3) (a) of the NCTE. Act, 1993, the Western Regional Committee hereby grants recognition to DISTRICT INSTITUTE OF EDUCATION AND TRAINING, PLOT NO. 3410, ROAD - RGT CAMPUS, DIST - PORBANDAR - 360575, GUJARAT (Code No. WRCAPP1519) for starting D.EL.Ed./P.T.C. course of Elementary level of 2 year duration with an annual intake of 50 from the academic Session 2014-15 as per the orders of the Hon'ble Supreme Court dated 13.12.2012 in W.P. (Civil) 276/2012.

Further, the institution is required to comply with all post-recognition conditions enumerated from clause 8(11) to clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations 2009.

The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or byc-laws, it shall intimate in writing with documentary evidence of its inability to do so.

The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009 for the academic session 2014-2015.

The recognition will operate for 2014-2015 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.
