REFUSAL ORDER

Whereas, in terms of section 14 of the NCTE Act, 1993, VIDYAMANDIR TRUST PALANPUR, PLOT NO. 5942, VIDYAMANDIR CAMPUS, TALEY BAUG, MEERA GATE PALANPUR, BANASKANTHA, Gujarat had applied on 23.09.2011 to the Western Regional Committee, NCTE for the grant of recognition to VIDYA MANDIR TRUST PALANPUR MANAGED ENGLISH MEDIUM B FD. COLLEGE, TALEY BAUG, VILL+ POST- PALANPUR, BANASKANTHA, Gujarat, for starting the B.ED. course.

And whereas, the deficiency letter was issued to the institution on 07.01.2012 giving 60 days time to remove the deficiencies. The reply to the deficiency letter was submitted by the institution on 03.03.2012.

And whereas. The matter was placed in 163rd meeting of WRC and the Committee decided to issue Show Cause Notice to the institution on the following points:-

- Certified copy of land documents not submitted.
- Approved building plan not submitted.
 - Total built up area is less than the NCTE norms.

And whereas, Show Cause Notice was issued to the institution on 07.07.2012. The reply to the Show Cause Notice was submitted by the institution on 07.08.2012 in the WRC office.

And whereas, the matter was placed in 169th meeting of WRC and the Committee decided to refuse recognition on the following grounds:-

The institution has still not submitted certified copy of the land documents and proper CLU.

Now therefore, the WRC in exercise of powers vested 14(3) (b) of the NCTE Act, hereby refuse recognition to VIDYA MANDIR TRUST PALANPUR MANAGED ENGLISH MEDIUM B.ED. COLLEGE, TALEY BAUG, VILL+ POST- PALANPUR, BANASKANTHA, Gujarat of the B.Ed. Course.

Further, if the institution is not satisfied by the order, they can prefer an online appeal to National Council for Teacher Education. Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
