### Withdrawal Order

WHEREAS Recognition/Permission was granted to the institute SMT. MANIBA MAHILA B.ED. COLLEGE, SHRI MONARK EDUCATION TRUST, AT. POST. VAHELAL, TA. DASCROI, AHMEDABAD 382350, GUJARAT under section 14 of NCTE Act, 1993 for conducting B.ED course with an intake of 100 from the academic session 2005-2006, vide order No. WRC/2-32/323133/71/2005/3599 dated 23.04.2005.

2. WHEREAS on the direction of the NCTE headquarters vide do letter No. 49-8/2008/NCTE (N & S) /78627 dated 21.05.2008 from NCTE, New Delhi directing WRC to conduct the inspection of 129 colleges of Gujarat u/s 17 of the NCTE Act 1993, as per the observation of Prin. A.U.Patel, the Chairman, fee/Admission Committee for self Finance B.ED/B.P.ED. course, Gujarat State & Formal Vice-Chancellor, Gujarat University. The Western Regional Committee had constituted a Visiting Team u/s 17 of NCTE Act, 1993 to Visit the institution.

3. AND WHEREAS, THE inspection of the institution was conducted on 07.06.2008.

4. AND WHEREAS, the matter was considered by the WRC in its 104<sup>th</sup> meeting of WRC hereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms:-

1. Area enmarked for B.Ed program be specified.
2. Whether the salary to staff is being paid through bank? Please specify.

5. AND WHEREAS the WRC directed that an opportunity be given the institution to make a written representation within 30 days from the date of the letter before withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a show cause notice was issued to the institution on 03.08.2008.

5. AND WHEREAS the matter was again considered by the Committee in its 109<sup>TH</sup> & 113<sup>TH</sup> meeting held on October 19-20, 2008 and having taken into consideration all the relevant facts of the case, it was decided to withdrawn recognition for conducting B.ED course from the academic session 2009-2010.

6. Now, therefore recognition to SMT. MANIBA MAHILA B.ED. COLLEGE, SHRI MONARK EDUCATION TRUST, AT. POST. VAHELAL, TA. DASCROI, AHMEDABAD 382350, GUJARAT in terms of section 17(1) of the NCTE Act, 1993 is hereby withdrawn from academic session 2009-2010 on the following grounds.

1. Non complaints of S/c notice within stipulated time.

7. Affiliating Body/ State Govt. are advises not to admit/ allot any student in B.ED in the said institute. In accordance to the section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposed of employment under the Center Government, any State Government or University, or in ant school, college or other educational body aided by the Central Government or any State Government.

8. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1- Bahadur Shah Zafar Marg, Near RTO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
