NO. 78, SERVEY NO. 235/1, VILLAGE, KHEJDIYA, THE JIRAPURA, DIST RAJGARH, MADHYA PRADESH** for Existing B.ED. (WRCAPP3099), D.EL.ED. (APW3104) Course.

3. **AND WHEREAS**, the matter of B.ED., D.EL.ED, was considered in WRC in its 295<sup>th</sup> Meeting held on 30<sup>th</sup>-31<sup>th</sup> July 2018, the Committee decided as under:-

ORDER FOR CHANGE OF NAME OF INSTITUTION


