AND WHEREAS, the institution, SITA RAM COLLEGE OF EDUCATION RUN BY GIRDHAR GOPAL SHIKSHA PRASAR EVAM JANKALYAN SAMITI, PLOT NO. -90/3, MAHOBA ROAD, VILLAGE – KHOP CHHATARPUR, P.O.+TEHSIL+DIST.-CHHATARPUR-471001, MADHYA PRADESH (WRCAPP2187/223) has by affidavit consented to come under New Regulations.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with statement of annual accounts duly audited by a Chartered Accountant.
