REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SSC EDUCATION COLLEGE, KHASARA NO. 22/8, PLOT NO. P.H. NO.51, VILLAGE/P.O. DORLICHHATARPUR, TEHSIL: SEONI, DISTRICT: SEONI- 480661, MADHYA PRADESH had submitted the application on 31/12/2012 to the Western Regional Committee of the NCTE for grant of recognition for starting the D.El.Ed. Course for an annual intake of 50 seats.

AND WHEREAS, the application of the institution was processed and deficiencies communicated to the institution vide letter dated 30.10.2013.

AND WHEREAS, the reply dated 22.11.2013 submitted by the institution was placed before WRC in its 197th meeting held from January 3-4, 2014 and the Committee decided that Show Cause Notice be issued to the institution u/s 14(3)(b) of NCTE Act, 1993. Accordingly, Show Cause Notice issued to the institution on 09.01.2014.

AND WHEREAS, reply submitted by the institution was placed before WRC in its 201st meeting held from February 19-22, 2014 and the Committee decided that Clarification be obtained from the institution. Accordingly, Clarification letter issued to the institution on 21.02.2014.

AND WHEREAS, reply submitted by the institution was placed before WRC in its 216th meeting held on February 12-13, 2015 and the Committee observed that "...The application is for D.El.Ed. received on 31.12.2012. Deficiency letter issued on 30.10.2013. The reply received was considered in the 197th meeting (3-4, January, 2014). A discrepancy was found in the khasra no. of the building plan and the khasra no. in the CLU. Hence, Show Cause Notice dated 09.01.2014 was issued. In the reply received on 17-18-Jan., 2014, it was seen that though the khasra no. is corrected in the CLU to 22/8, the diverted land was only 0.14 hectares, which is less than as required under the NCTE Norms. Hence, a letter dated 21.02.2014 was issued to obtain Clarification. The applicant has again submitted photocopies of the old building completion certificate and the photocopy of the same CLU, which shows diverted area as 0.14 hectares. In his letter dated 22.02.2014, the applicant has claimed that the diversion of 0.14 hectares is sufficient since, the first floor has also been built by him. It seems, that the applicant is mixing up built up area with the requirement of diverted area. Since, Show Cause Notice, and letter for Clarification on these same issues have already been issued, no further opportunity can be given. **Hence, Recognition is refused.**"

NOW, THEREFORE, the WRC, in exercise of powers vested u/s 14(3) (b) of the NCTE Act, hereby refuses recognition to SSC EDUCATION COLLEGE, KHASARA NO. 22/8, PLOT NO. P. H. NO.51, VILLAGE /P.O. DORLICHHATARPUR, TEHSIL: SEONI, DISTRICT: SEONI-480661, MADHYA PRADESH for the D.El.Ed. Course.

Further, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
