Restoration Order

WHEREAS, recognition was granted to the institution namely, SUBHASH CHANDRA BOSE COLLEGE, B- 81, 83, GOVINDPURI, NEAR JIWAJI UNIVERSITY, GWALIOR- 474011, MADHYA PRADESH for B.ED. Courses vide order No. WRC/5-6/48/2003/4487-93 dated 27.10.2003 with an annual intake of 100 seats.

AND WHEREAS the recognition of B.ED course of the said institution was refused by WRC vide order No. NCTE/WRC/MP/Legal/APW00097/223140/115th/2009/53719 dated 11.04.2009.

AND WHEREAS, the institution preferred an appeal against the aforesaid order. The Council vide order dated 23.08.2010 reached the conclusion that there was no ground to accept the appeal and that it should be rejected, but the WRC is directed to issue a modified order withdrawing the recognition of the institution u/s 17 of the NCTE Act.

AND WHEREAS, the institution filed W.P. No.7549/2010 in the Hon'ble High Court of M.P. Bench at Gwalior. The Hon'ble High Court passed an order dated 10.03.2011.

AND WHEREAS, the court order was placed before WRC in its 149th meeting held from May 4-6, 2011 and the Committee decided that name of the institution be included in the list of recognized institutions for 2010-2011 only. No admissions be made in session 2011-2012 until further decision of WRC and further consideration of the case is deferred as the matter is sub-judice with the Supreme Court.

AND WHEREAS, as per judgment dated 12.04.2012 of Hon'ble Supreme Court of India, inspection of the institution was conducted by NCTE Hqrs u/s 13 on 23.05.2012.

AND WHEREAS, letter communicating deficiencies was issued on 01.08.2012, the reply submitted by the institution on 29.08.2012 was placed before WRC in its 177th meeting held from January 7-8, 2013 and the Committee observed that clarification be sought from the institution. Accordingly, clarification letter was issued to the institution on 06.02.2013.

AND WHEREAS, the reply submitted by the institution on 06.03.2013 was placed before WRC in its 181st Meeting held from March 18-20, 2013 and the Committee decided that "In response to the letter of Clarification dated 06.02.2013, the institution has submitted the required documents and rectified the shortcomings. Hence, Recognition be restored."


NOW THEREFORE, the Western Regional Committee hereby restores the recognition granted to **SUBHASH CHANDRA BOSE COLLEGE, B- 81, 83, GOVINDPURI, NEAR JIWAJI UNIVERSITY, GWALIOR- 474011, MADHYA PRADESH** for conducting **B.ED.** course with an annual intake of **100 seats** with the same terms and conditions as mentioned in the recognition order dated **27.10.2003**.
