Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

And whereas, the institution, Shiksha Vibhag, Atal Bihari Vajpayee Hindi Vishwavidyalaya, Campus, Old Vidhan Sabha Building, (Minto Hall), Malviya Nagar, Opposite Raj Bhawan, Bhopal, Madhya Pradesh 462003, (WRCAPP2503) has by affidavit consented to come under New Regulations.

And Whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. programme, such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
