RESTORATION ORDER

WHEREAS, the recognition was granted to the institution namely **VIDHIK SHAIKSHANIK SANSTHAN, PIPAL CHAURAHA, KAROND, BERASIA ROAD, BHOPAL, MADHYA PRADESH** for **B.ED.** course vide order No. WRC/2-32/223278/76/2005/6199 dated 09.08.2005 with an annual intake of 100 seats.

AND WHEREAS, the recognition of B.ED course of the said institution was refused by WRC vide order No.NCTE/WRC/MP/Legal/APW01629/223278/115th/2009/53331-53336 dated 06.04.2009.

AND WHEREAS, the institution had preferred an appeal under Section 18 of the NCTE Act 1993, before the Council against the aforesaid order and the Appellate Authority vide order dated 18.08.2009 directed that the orders issued by WRC for refusal of recognition under section 14(3)(b) needed modification to the extent that recognition of the institution be withdrawn under section 17 of the NCTE Act, with prospective effect.

AND WHEREAS, the Hon'ble High Court of M.P., Principal Seat at Jabalpur passed an interim order dated 13.04.2011 in W.P. No.2343/2011.

AND WHEREAS, the court order was placed before WRC in its 149th meeting held from May 4-6, 2011 and the Committee decided that VT be constituted for inspection of the new premises.

AND WHEREAS, the Hon'ble High Court of Madhya Pradesh, Principal Seat at Jabalpur disposed of the W.P. No.2343/2011 vide order dated 16.05.2012.

AND WHEREAS, the aforesaid court order was placed before WRC in its 166th meeting held from July 9-10 2012 and the Committee observed that in this case the Hon'ble High Court had passed an order on 16.5.2012 according to which Respondent No. 1 has to pass fresh order within of 60 days from the date of conducting inspection of the premises of the petitioner. Hence, WRC decided that the case be forwarded immediately to NCTE Hqrs. at New Delhi. Accordingly, letter was sent to the NCTE Hqrs on 18.07.2012.

AND WHEREAS, the inspection of the institution was conducted by NCTE Hqrs u/s 13 on 27.01.2013 and deficiency letter was issued to the institution on 25.03.2013.

AND WHEREAS, the reply submitted by the institution on 10.04.2013 was placed before WRC in its 182nd meeting held from April 16-17, 2013 and the Committee decided that clarification be sought from the institution. Accordingly, clarification letter was issued to the institution on 14.05.2013.

AND WHEREAS, the reply submitted by the institution on 08.05.2013 was placed before WRC in its 187th meeting held from July 25-26, 2013 and the Committee decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued on 06.08.2013.

AND WHEREAS, the reply submitted by the institution on 05.08.2013 was placed before WRC in its 190th meeting held from September 18-20, 2013 and the Committee observed that "Recognition was withdrawn vide order dated 06.04.2009. On the basis of the order of the Hon'ble High Court dated 16.05.2012, the case of the institution was taken up and it was asked to submit staff profile, which was done. The only lacuna was the experience of the Principal. Now the institution has submitted certificates from two colleges where the person appointed as Principal has taught. The period adds upto 9½ years which is accepted as 10 academic years. Hence, Recognition is restored."
