**ORDER**

WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to V.N.S. COLLEGE OF EDUCATION, PHYSICAL EDUCATION, VNS CAMPUS VIDYA VIHAR BARKHEDA NATHU NEELBAD BHOPAL- 462044, MADHYA PRADESH for D.Ed. course vide order dated 15.09.2006 for an annual intake of 50 seats.

AND WHEREAS, the institution applied for change of name from V.N.S. COLLEGE OF EDUCATION, PHYSICAL EDUCATION to **VNS COLLEGE OF PHYSICAL EDUCATION AND MANAGEMENT STUDIES.**

AND WHEREAS, the matter was placed in 228<sup>th</sup> Meeting of WRC held on June 15-16, 2015 and the Committee decided that "...The institution has requested that its name be changed from 'VNS College of Education, Physical Education AND' to 'VNS College of Physical Education and Management Studies'. The institution has deposited a DD of Rs.50,000/- alongwith a resolution of the Society. **Hence, change of name is permitted. WRO to check up whether the fee deposited for change of name is as per the present norms.**"

NOW THEREFORE, the permission is hereby granted for change of name from V.N.S. COLLEGE OF EDUCATION, PHYSICAL EDUCATION to **VNS COLLEGE OF PHYSICAL EDUCATION AND MANAGEMENT STUDIES** with immediate effect.
