WHEREAS, in terms of Section 14 of the NCTE Act, 1993, AS

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, ASHOK KUSUM SHIKSHA PRASAR SAMITI, PLOT NO: 381, 382, STREET: B.T.I ROAD, VILLAGE: BHIND, POST OFFICE: BHIND, TEHSIL: BHIND, DISTRICT: BHIND-477001, MADHYA PRADESH had submitted the online application on 26.05.2015 to the Western Regional Committee of the NCTE for grant of recognition to SHRIRAM COLLEGE, PLOT NO: 381, 382, STREET: B.T.I ROAD, VILLAGE: BHIND, POST OFFICE: BHIND, TEHSIL: BHIND, DISTRICT: BHIND- 477001, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 20.07.2015 requesting to give their recommendation/comments and reminder letter to the State Government was issued on 01.10.2015.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10:2015 has given the recommendation.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-"... The VT has been Constitued at office level."

AND WHEREAS, the Regional Director, WRO constituted the Visiting team.

AND WHEREAS, the inspection letter issued to the institution on 10.02.2016 and the inspection conducted of the institution on 16.02.2016.

AND WHEREAS, the matter was placed before the WRC in its 243rd Meeting held on February 18-20, 2016, the committee observed that:- "...The VT went for the inspection on 16/02/2016. However, the applicant refused for the inspection on the plea that no notice of the inspection was given to him. The WRO states that all methods of intimation of inspection were given to the applicant.

Hence, VT be reconstituted after the applicant deposits the fee of Rs. 1.50 lakhs.

The applicant should also be asked to submit the notarized copies of the following documents: Non-Encumbrance Certificate, Building Plan, Building Completion Certificate, CLU. FDRs also be obtained."

AND WHEREAS, the Clarification letter was issued to the institution on 23.02.2016 and the reply has not been received.

AND WHEREAS, the matter was placed before the WRC in its 253rd Meeting held on May 24-26, 2016 and the Committee observed that "...The WRO had send a letter to the institution on 23/02/2016 for re-submission of the fee of Rs. 1.50 lakhs and for submission of other documents. The institution has not replied till date.

Show Cause Notice be issued on the above ground."

AND WHEREAS, the Show Cause Notice was issued to the institution on 02.06.2016 and the institution has not submitted the reply till date.

AND WHEREAS, the matter was placed before the WRC in its 266th Meeting held on January 10-12, 2017 and the Committee observed that "...Clarification letter/Show Cause Notice dt. 02/06/2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to SHRIRAM COLLEGE, PLOT NO: 381, 382, STREET: B.T.I ROAD, VILLAGE: BHIND, POST OFFICE: BHIND, TEHSIL: BHIND, DISTRICT: BHIND- 477001, MADHYA PRADESH for B.ED. Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order though online Mode using website www.ncte-india.org.
