WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, PT LT SHRI LALLURAM SHIKSHA AVAM JANKALYAN SEWA SAMITI, PLOT NUMBER 1858/53/1, STREET/ROAD - SATAI ROAD, VILLAGE/TOWN/CITY - BAGOUTA CHHATARPUR, POST OFFICE/TEHSIL/TALUKA /TOWN/CITY/DISTRICT - CHHATARPUR, PIN CODE - 471001, MADHYA PRADESH (APP2428/222) had submitted on 31.12.2012 the application to the Western Regional Committee of the NCTE for grant of recognition to SIDDHI VINAYAK COLLEGE OF EDUCATION, PLOT/KHASRA NO.1858/53/1, STREET/NUMBER - SATAI ROAD, VILLAGE - BAGOUTA CHHATARPUR, POST OFFICE/TEHSIL/TALUKA /TOWN/CITY/DISTRICT - CHHATARPUR, PIN CODE - 471001, MADHYA PRADESH for D.El.Ed. AND WHEREAS, WRC in its 292nd meeting held on May 15-17, 2018 decided that, "...Recognition be granted for one unit of D.El.Ed. course from the academic session 2019-2020." Accordingly, Recognition order issued on 28.05.2018.

AND WHEREAS, the institution thereafter filed W.P. No.603/2018 before the Hon'ble Supreme Court of India and the Hon'ble Court had passed an order dated 21.06.2018 that, "The petitioner is permitted to file a representation for grant of recognition for the academic session 2018-2019 within two days from today. Respondent No.1 is directed to consider the said representation within a period of ten days from today."
