#### Show Cause Notice under section 17 of NCTE Act, 1993

Whereas, the recognition was granted to the institution namely, A. G. Teacher's College, (CTE), Navrangpura, Gujarat for B.Ed. Course vide order no WRC/5-6/2k/499-504 dt. 18.01.2001.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the A. G. Teacher's College, (CTE), Navrangpura, Gujarat offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 12.01.2015 from the institution, a revised recognition order no. WRC/313025/2015/137006 dt. 26.05.2015 was issued to the institution for conducting B.Ed. course with an annual intake of 50 seats (one basic units of 50 students) from session 2015-16.

And whereas, reply of institution in compliance of revised order had not submitted.

And whereas, file placed before the WRC in its  $255^{th}$  meeting held on June,  $22^{nd}$  –  $24^{th}$ , 2017 and the Committee decided to issue Show Cause Notice. Accordingly a show cause notice dt. 10.08.2016 was issued.

And whereas, the institution vide letter no. 172/2016-17 dt. 10.09.2016 has submitted the reply.

And whereas, reply dt. 10.09.2016 submitted by the institution was placed before the WRC in its  $277^{th}$  meeting held on June,  $29^{th}$  - 30th, 2017 and the Committee decided to issue Show Cause Notice on following points:-

"The case file was seen. In response to the WRC letter dt. 10/08/2016, regarding fulfillment of requirements for 1 unit of the B.Ed. course, the institution has submitted a list of 1 Principal and 6 faculty members.

The needs to appoint 1 more faculty member in Physical Education.

As per NCTE Regulations, 2014, FDRs for 12 lakhs in joint operation with the RD, WRC is required. The institution should also fulfill this condition.

Show Cause Notice be issued on the above grounds and reply should be received within 1 month."

Therefore, in compliance of the decision of the WRC this Show Cause Notice is issued u/s 17 of NCTE Act, 1993 with the direction to submit your written representation with in a period of 30 days from the date of dispatch of this notice.

However, if your written representation is not received within 30 days, it will be presumed that you have nothing to say, and in that event the WRC shall be free to take its decision as per the Regulations of NCTE.



- And whereas, it was decided to permit the institution to have one basic unit of 50 students each unit (one unit of 50 students each) subject to the institution fulfilling following conditions, namely:
- The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31st, 2015.
- The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before *October 31<sup>st</sup>*, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the visiting team at the time of inspection.
- The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by October 31st, 2015. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.
- 4. And whereas, in light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) issued the revised recognition order to A.G. Teacher's College, (CTE), Navrangpura, Ahmedabad, Gujarat for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic unit of 50 students) each unit from the academic session 2015-16 subject to fulfillment of the above conditions.

And whereas, the date for compliance regarding faculty was extended by the NCTE Hqrs. upto 29th February, 2016 and for additional built up area and addl. FDRs in the joint name, upto 30th May, 2016.

In compliance of the decision of the WRC, the Show Cause Notice is issued to the institution under Section 17(1) of the NCTE Act, 1993. The institution is directed to submit written representation within a period of 21 days from the date of this Notice. In the event, -[this office does not receive any reply, it will be presumed that the institution has nothing to say and the Regional Committee shall take action for withdrawal of recognition.

Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- 6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
  - a) Sanctioned programmes along with annual intake in the institution:
  - Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c) Name of faculty members who left or joined during the last, quarter:
  - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e) Fee charged from students;
  - f) Available infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i) The affidavit with enclosure submitted along with application.
  - j) The institution shall be free to post additional relevant information, if it so desires.
  - Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

#### ORDER

In exercise of the powers vested under section 14(3) (a) of the National Council for Teacher Education(NCTE) Act, 1993, the Western Regional Committee grants recognition to A.G. Teacher's College, (CTE), Navrangpura, Ahmedabad for B.Ed. course from the academic session 2000-2001 with an annual intake of 60 students, subject to fulfilling the following conditions:

- 1. All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
- The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
  - The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/State Government.
- 4. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
- 5. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating university/examining body.
- 6. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
- 7. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
- 8. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 7 above.
