



1. Whereas in terms of section 14(1) of the NCTE Act 1993 **ADARSH MAHILA PRIMARY TEACHER COLLEGE OF EDUCATION, AT-POST- NAPA, TAL. BORSAD, NEAR GOVT. DISPENSARY, DIST. ANAND ANAND GUJARAT** is already a recognized institution for **P.T.C. Course (ELE)** of two year duration with an annual intake of **50** (fifty) students.
2. Institution applied for shifting of institute from "ADARSH MAHILA PRIMARY TEACHER COLLEGE OF EDUCATION, AT-POST- NAPA, TAL. BORSAD, NEAR GOVT. DISPENSARY, DIST. ANAND ANAND GUJARAT" to "ADARSH MAHILA PRIMARY TEACHER COLLEGE OF EDUCATION, MUSLIM VIDHYARTHI PRAGATI MANDAL TRUST, PLOT NO. S.NO. 4/2, AT-POST- NAPA, DIST. ANAND, GUJARAT", A committee in this regard was constituted by the WRC and visiting team inspected its new premises on dated **19.04.2008**.
3. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the state government, the committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, rules and relevant regulations including the norms and standards for the elementary teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms, and in the 105th WRC meeting, the committee accepted the request of the institute i.e Shifting of premises, *subject to the condition that documents regarding appointment of qualified principal be submitted within 90 days of the receipt of this letter.*
