#### Show Cause Notice under section 17 of NCTE Act, 1993

Whereas, the recognition was granted to the institution namely, Amity B.Ed. College, Gyanoday Educational Trust, Plot No. 106, Khasra NO. 100, Umaraj, Bharuch, Gujarat for B.Ed. Course vide order no WRC/5-6/106<sup>th</sup>/2008/40314 dt. 28.08.2008.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Amity B.Ed. College, Gyanoday Educational Trust, Plot No. 106, Khasra NO. 100, Umaraj, Bharuch, Gujarat offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 12.01.2015 from the institution, a revised recognition order no. WRC/APW05887/323464/B.Ed.(Revised Order)/2015/143588 dt. 31.05.2015 was issued to the institution for conducting B.Ed. course with an annual intake of 100 seats (two basic units of 50 students) from session 2015-16.

And whereas, reply of institution in compliance of revised order had not submitted.

And whereas, file placed before the WRC in its  $255^{th}$  meeting held on June,  $22^{nd}$  –  $24^{th}$ , 2017 and the Committee decided to issue Show Cause Notice. Accordingly a show cause notice dt. 29.08.2016 was issued.

And whereas, the institution vide letter no. 352/B.Ed./2016 dt. 19.08.2016 has submitted the reply.

And whereas, reply dt. 19.08.2016 submitted by the institution was placed before the WRC in its 277<sup>th</sup> meeting held on June, 29<sup>th</sup> - 30th, 2017 and the Committee decided to issue Show Cause Notice on following points:-

"The case file was seen. In response to the WRC letter ct. 29/08/2016, regarding fulfillment of requirements the institution has represented that it had requested only for 1 unit (50 students). The institution has submitted a list of5 faculty members for 1 unit of the B.Ed. course.

The institution needs to appoint a Principal and 2 more faculty members as NCTE Regulations, 2014.

Show Cause Notice be issued on the above grounds and reply should be received within 1 month."

Therefore, in compliance of the decision of the WRC this Show Cause Notice is issued u/s 17 of NCTE Act, 1993 with the direction to submit your written representation with in a period of 30 days from the date of dispatch of this notice.

However, if your wsritten representation is not received within 30 days, it will be presumed that you have nothing to say, and in that event the WRC shall be free to take its decision as per the Regulations of NCTE.

Whereas, recognition was granted to the institution, President College of Education Amity B.ED College Gyanoday Educational Trust, Plot No. 106, Khasra No. 100, Umaraj, Bharuch, Gujarat for conducting B.Ed course of one year duration vide order No. WRC/5-6/106<sup>th</sup>/2008/40314 dt 28.08.2008 with an intake of 100 students

And whereas, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 13.10.2000.

- And whereas, the institution by a notarized affidavit dt. 12.01.2015 consented to come under new Regulations and sought for one unit of B.ED. Course which required additional facilities.
- And whereas, it was decided to permit the institution to have two basic units of 100 students (two units of 50 students each) subject to the institution fulfilling following conditions, namely
- The institution shall create additional facilities that include (a) additional built-up area. (b) additional infrastructure, (c) additional funds (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31st, 2015.
- The applicant-institution for additional unit will be required to submit the required documents such as land documents. Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before October 31<sup>st</sup>, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the visiting team at the time of inspection
- The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by October 31st, 2015. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.
- 4. And whereas, in light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) issued the revised recognition order to Education Amity B.ED College, Gyanoday Educational Trust, Plot No. 106, Khasra No. 100, Umaraj, Bharuch, Gujarat for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the above conditions.

And whereas, the date for compliance regarding faculty was extended by the NCTE Hqrs upto 29th February, 2016 and for additional built up area and addl. FDRs in the joint name, upto 30<sup>th</sup> May, 2016.

- Originally notarized CLU (Certificate for Land Use), Non-Encumbrance Certificate, Approved Building Plan and Building Completion Certificate issued by Engineer of Rural Engineering Service or PWD Engineer.
- FDRs of Rs. 5 lakhs, as Endowment Fund, and of Rs. 7 lakhs, as Reserve Fund per unit, in joint operation with Regional Director, WRC (NCTE), Bhopal

In compliance of the decision of the WRC, the Show Cause Notice is issued to the institution under Section 17(1) of the NCTE Act, 1993. The institution is directed to submit written representation within a period of 21 days from the date of this Notice. In the event, -[this office does not receive any reply, it will be presumed that the institution has nothing to say and the Regional Committee shall take action for withdrawal of recognition.

9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:

- Copy of the Application Form (i)
- Land and Building Particulars. (ii)
- Staff Profile. (iii)
- Information for having fulfilled the norms & standard and other required conditions. Recognition letter. (iv)

11. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

12. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
